Act No. 4 of 2010

An Act to amend the *Counter Terrorism and Transnational Organised Crime Act 2004*.

Certified on 18 November 2010

Enacted by the Parliament of Nauru as follows:

1 Short title

This Act may be cited as the *Counter Terrorism and Transnational Organised Crime (Amendment) Act 2010*.

2 Commencement

This Act commences on the date the Speaker certifies that it has been passed by Parliament under Article 47.

3 Act amended

The Schedule amends the *Counter Terrorism and Transnational Organised Crime Act 2004*.
