An Act to provide for the confiscation of the proceeds of serious offences.

Enacted by the Parliament of Nauru as follows:

PART 1 — PRELIMINARY

1 Short title and commencement

- (1) This Act may be cited as the *Proceeds of Crime Act 2004*.
- (2) This Act comes into force upon certification by the Speaker and came into effect on 3 November 2004.

2 Objectives

The objectives of this Act are to:

- (a) deprive persons of the proceeds of, and benefits derived from, the commission of serious offences;
- (b) provide for the forfeiture of property used in, in connection with, or for facilitating, the commission of serious offences; and
- (c) enable law enforcement authorities to trace those proceeds, benefits and property.

3 Definitions

- (1) In this Act:

‘authorised officer’ for the provisions of this Act, means a person, or a person in a class of persons, designated, in writing by the Minister, as an authorised officer;

‘benefit’ has the meaning given by Section 4;

‘charge’ in relation to an offence, includes any procedure by which criminal proceedings are commenced against a person;

‘Commissioner’ means the Commissioner of Police;

‘conviction’ has the same meaning given by Section 5(1);

‘court’ means the District Court;

‘currency’ means coin and paper money that is legal tender in its country of issue;

‘dealing with property’ includes:

- (a) for property that is a debt, making a payment to the creditor in reduction or discharge of the debt;
- (b) giving or receiving property as a gift; and
- (c) removing property from the Republic;

‘defendant’ means a person charged with a serious offence, whether or not he or she has been convicted of the offence; and, for proceedings for a restraining order, includes a person who is likely to be charged with a serious offence;

‘document’ means a record of information in any form, including:

- (a) a written or printed thing, including a map, plan, graph or drawing;
- (b) a computer file, including a record that is kept in electronic form and can be accessed in the Republic;
- (c) a photograph;
- (d) a disk, tape, film soundtrack or other thing in which sound or other data is embodied; and
- (e) a film, negative, tape or other thing in which a visual image is embodied;

‘effective control’ has the meaning given by Section 4A;

‘financial institution’ has the same meaning given by the *Anti-Money Laundering and Targeted Financial Sanctions Act 2023*;

‘Financial Intelligence Unit’ means the Financial Intelligence Unit continued in existence under the *Anti-Money Laundering and Targeted Financial Sanctions Act 2023*;

‘foreign forfeiture order’ has the same meaning given by Section 3 of the *Mutual Assistance in Criminal Matters Act*;

‘foreign pecuniary penalty order’ has the same meaning given by Section 3 of the *Mutual Assistance in Criminal Matters Act*;

‘foreign restraining order’ has the same meaning given by Section 3 of the *Mutual Assistance in Criminal Matters Act*;

‘foreign serious offence’ means a serious offence against the law of a foreign country;

‘forfeiture order’ means an order under Section 17(1);

‘gift’ has the meaning given by Section 8;

‘gift caught by this Act’ has the meaning given by Section 10;

‘interest’, for property, means:

- (a) a legal or equitable estate or interest in the property; or
- (b) a right, power or privilege in connection with the property;

‘Judge’ has the same meaning given to it under the *Constitution and Supreme Court Act 2018*;

‘Minister’ means the Minister for Justice and Border Control;

‘Mutual Assistance in Criminal Matters Act’ means the *Mutual Assistance in Criminal Matters Act 2004*;

‘pecuniary penalty order’ means an order made under Section 26(1);

‘police officer’ means a member of the Nauru Police Force;

‘proceedings’ includes any procedure, including an inquiry, investigation, or preliminary or final determination of facts, conducted by or under the supervision of a Judge or Resident Magistrate in connection with:

- (a) an alleged or proven offence; or
- (b) property derived from that offence;

‘proceeds’, in relation to property, means property into which any property

derived or realised directly from a serious offence was later successively converted, transformed or intermingled, as well as income, capital or other economic gains derived or realised from such property at any time since the commission of the offence, whether the property is situated in the Republic or elsewhere;

‘production order’ means an order under Section 78;

‘property’ includes money and all other property, real or personal, whether situated in the Republic or elsewhere, including an enforceable right of action and other intangible or incorporeal property;

‘property of, or in the possession or control of a person’ includes property that is subject of a gift;

‘property-tracking document’ for an offence, means a document relevant to:

- (a) identifying, locating or quantifying property of a person who committed the offence;
- (b) identifying or locating any document necessary for the transfer of property of a person who committed the offence;
- (c) identifying, locating or quantifying tainted property in relation to the offence; or
- (d) identifying or locating any document necessary for the transfer of tainted property in relation to the offence;

‘quash’ has the meaning given by Section 5(2), (3) and (4);

‘realisable property’ has the meaning given by Section 6;

‘relevant application period’ for a person’s conviction of a serious offence, means the period of 6 years after:

- (a) if the person was actually convicted of the offence, the day when the person was convicted of the offence;
- (b) if the person is taken to have been convicted of the offence because of Section 5(1)(b), the day when the person was discharged without conviction; or
- (c) if the person is taken to have been convicted of the offence because of Section 5(1)(c), the day when the court took the offence into account in passing sentence for the other offence referred to in that Section;

‘restraining order’ means an order made under Section 50 or 63;

‘Secretary for Justice’ includes the Director of Public Prosecutions, where the context requires;

‘serious offence’ means:

- (a) acts or omissions that constitute an offence against the written laws of the Republic punishable by imprisonment for not less than 2 years or the imposition of a fine of more than \$5,000;
- (b) acts or omissions that constitute an offence against the law of another country that, had those acts or omissions occurred in the Republic, they would have constituted an offence against the law of the Republic punishable by imprisonment for not less than 2 years or the imposition of a fine of more than \$5,000;

- (c) financial crime and criminal conduct under the *Anti-Money Laundering and Targeted Financial Sanctions Act 2023*; or
- (d) offences under the *Counter Terrorism and Transnational Organised Crime Act 2004*;

‘tainted property’ means:

- (a) property that is used in, or in connection with, the commission of a serious offence whether situated in the Republic or elsewhere;
- (b) property that is intended to be used in, or in connection with the commission of a serious offence whether situated in the Republic or elsewhere;
- (c) proceeds of that offence;
- (d) criminal property under the *Anti-Money Laundering and Targeted Financial Sanctions Act 2023*; or
- (e) terrorist property under the *Counter Terrorism and Transnational Organised Crime Act 2004*;

‘trust’ means an arrangement in which a person:

- (a) invests funds in a trust;
- (b) is a beneficiary under a trust; and
- (c) receives profit or income from the acquisition, holding, management or disposal of property under the trust; and

‘unlawful activity’ means an act or omission that constitutes an offence against a law of the Republic or of a foreign country.

‘Administrator’ means the Secretary for Justice or the person appointed by the Minister under Section 102;

‘appeal’ includes proceedings by way of discharging or setting aside a judgment, and an application for a new trial or for a stay of execution;

- (2) A reference in this Act to the law of a country includes:
 - (a) both the written and unwritten law of the country; and
 - (b) a law in force in a part of the country.

4 Meaning of “benefit”

For the purposes of this Act:

- (a) a person benefits from an offence if the person receives, at any time, any payment or other reward in connection with, or derives any pecuniary advantage from, the commission of the offence; and
- (b) a reference to a benefit derived or obtained by, or otherwise accruing to, a person includes a benefit derived or obtained by, or otherwise accruing to, another person at the first mentioned person’s request or direction.

4A Meaning of “effective control”

- (1) Property may be subject to the effective control of a person whether or not the person has:
 - (a) a legal or equitable estate or interest in the property; or
 - (b) a right, power or privilege in connection with the property.
- (2) Property that is held on trust for the ultimate benefit of a person is taken to be under the effective control of the person.

- (3) The property is taken to be under the effective control of a person if:
 - (a) property is initially owned by such person; and
 - (b) within 6 years either before or after an application for a restraining order or a confiscation order is made, the property is disposed of to another person without sufficient consideration.
- (4) In determining whether or not property is subject to the effective control of a person, the effect of any order made in relation to the property under this Act is to be disregarded.
- (5) In determining whether or not property is subject to the effective control of a person, regard may be had to:
 - (a) shareholdings in debentures over or directorships of a corporation that has an interest whether direct or indirect in the property;
 - (b) a trust that has a relationship to the property; and
 - (c) family, domestic and business relationships between persons having an interest in the property or in companies of the kind referred to in paragraph (a) or trusts of the kind referred to in paragraph (b) and other persons.
- (6) For the purposes of this Section, family relationships include but are not limited to the following:
 - (a) relationships between de-facto partners;
 - (b) relationships of child and parent; or
 - (c) relationships traced through relationships mentioned in paragraphs (a) and (b).
- (7) To avoid doubt, property may be subject to the effective control of more than one person.

5 Meaning of “conviction” and “quash”

- (1) For the purposes of this Act, a person is taken to have been convicted of an offence if:
 - (a) the person was convicted of the offence;
 - (b) the person was charged with, and found guilty of the offence, but is discharged without conviction; or
 - (c) the person was not found guilty of the offence, but the court, with the consent of the person, takes the offence into account in passing sentence on the person for another offence.
- (2) Where a person is taken, under subsection (1)(a), to have been convicted of an offence, for this Act, the conviction is taken to have been quashed if the person is granted a pardon in relation to the offence.
- (3) Where a person is taken, under subsection (1)(b), to have been convicted of an offence, for this Act, the conviction is taken to be quashed if the finding of guilt is quashed or set aside.
- (4) Where a person is taken, under subsection (1)(c), to have been convicted of an offence, for this Act:
 - (a) the conviction is taken to be quashed if the court’s decision to take the offence into account is quashed or set aside; and
 - (b) the conviction is not taken to be quashed only because the person’s conviction for the offence for which he or she was sentenced is quashed or set aside.

6 Meaning of “realisable property”

- (1) In this Act, ‘*realisable property*’ means any property held by a person:
 - (a) who has been convicted of, or charged with, a serious offence; or
 - (b) to whom a person so convicted or charged has directly or indirectly made a gift caught by this Act.
- (2) A property is not realisable property if:
 - (a) there is in force against the property a forfeiture order made under this or another written law; or
 - (b) a forfeiture order is proposed to be made against the property under this or another written law.

7 How value of property is worked out

- (1) Subject to subsection (2), for the purposes of this Act, the value of property, other than currency, to a person holding the property, is:
 - (a) if another person holds an interest in the property, the market value of the person’s beneficial interest in the property, less the amount required to discharge any encumbrance on that interest; or
 - (b) in any other case, its market value.
- (2) For the purposes of this Act, the value at a particular time of a transfer of property is the greater of:
 - (a) the value of the property to the recipient when he or she receives it, adjusted to take account of subsequent changes in the value of money; and
 - (b) the value to the recipient at that time of:
 - (i) the property; or
 - (ii) the property that, in whole or in part, directly or indirectly represents, in the recipient’s hands, the property that he or she received.

8 Meaning of “gift”

- (1) For the purposes of this Act, ‘*gift*’ includes a transfer, directly or indirectly, of property by one person to another for a consideration that is significantly less than the value of the property.
- (2) In the circumstances mentioned in subsection (1), Sections 9 and 10 apply as if the person had made a gift of as much of the transferred property as bears to the whole property the same proportion as the difference between the value of the property and the value of the consideration.

9 Value of a gift

- (1) For the purposes of this Act, the value at a particular time of a gift is the greater of:
 - (a) the value of the gift to the recipient when he or she received it, adjusted to take account of changes in the value of money; or
 - (b) if subsection (2) applies, the value mentioned in subsection (2).
- (2) Where, at a particular time, a person holds:
 - (a) property, other than currency, that the person received as a gift; or
 - (b) property that, in whole or in part, directly or indirectly represents, in the person’s hands, property that the person received as a gift,

the value of the gift is the value to the person at that time of:

- (i) the property mentioned in paragraph (a); or
- (ii) the property mentioned in paragraph (b), so far as it represents the property that the person received.

10 Meaning of “gift caught by this Act”

- (1) A gift made by a person convicted of or charged with a serious offence, including a gift made before the commencement of this Act, is caught by this Act if:
 - (a) it was made after the commission of the offence or, if more than one, the earliest of the offences to which the proceedings for the time being relate and the court considers it appropriate in all the circumstances to take the gift into account; or
 - (b) it was made by the person convicted or charged at any time and was a gift of property:
 - (i) received by the person in connection with the commission of a serious offence committed by the person or by another person; or
 - (ii) that, in whole or in part, directly or indirectly represented in the person’s hands, property received by the person in that connection.
- (2) For the purposes of subsection (1), “offences to which the proceedings for the time being relate” includes, if those proceedings have resulted in the conviction of the person, a reference to any offence that the court takes into consideration when determining the sentence.

**PART 2 — FORFEITURE ORDERS, PECUNIARY PENALTY ORDERS AND
RELATED MATTERS**

DIVISION 1 — GENERAL

11 Application for forfeiture order or pecuniary penalty order on conviction

- (1) Where a person is convicted of a serious offence committed after this Act commences, the Secretary for Justice may apply to the court for either or both of the following orders:
 - (a) a forfeiture order against tainted property; or
 - (b) a pecuniary penalty order against the person for benefits derived by the person from the commission of the offence.
- (2) The Secretary for Justice may not make an application after the end of the relevant application period for the conviction.
- (3) An application under this Section may be made for one or more serious offences.
- (4) After an application under this Section is finally determined, no further application for a forfeiture order or a pecuniary penalty order may be made for the offence for which the person was convicted without leave of the court.
- (5) The court may give leave for a new application only if:
 - (a) the property or benefit to which the new application relates was identified after the previous application was determined;
 - (b) necessary evidence became available only after the previous application was determined; or
 - (c) it is in the interests of justice that the new application be made.
- (6) Every application shall:
 - (a) in the case of an application for a forfeiture order, identify the property that is alleged to be tainted property; and
 - (b) in the case of an application for a pecuniary penalty order, identify the benefits that are alleged to have been derived from the commission of the offence.

12 Notice of application

- (1) Where the Secretary for Justice applies for a forfeiture order against tainted property in relation to a serious offence for which a person is convicted:
 - (a) the Secretary for Justice shall give reasonable written notice of the application to the person and to any other person whom the Secretary for Justice has reason for believing may have an interest in the property;
 - (b) the person, and any other person who claims an interest in the property, may appear and adduce evidence at the hearing of the application; and
 - (c) the court may, at any time before the final determination of the application, direct the Secretary for Justice:

- (i) to give reasonable written notice of the application to any person who, in the opinion of the court, appears to have an interest in the property; or
 - (ii) to publish notice of the application, containing the particulars that the court directs and as often as the court directs, in the Government Gazette or any other form of media in the Republic.
- (2) Where the Secretary for Justice applies for a pecuniary penalty order against a person:
- (a) the Secretary for Justice shall give the person reasonable written notice of the application; and
 - (b) the person may appear and adduce evidence at the hearing of the application.

13 Amendment of application

- (1) The court may, before finally determining an application for a forfeiture order or pecuniary penalty order, and on the application of the Secretary for Justice, allow the amendment of the application to include any other property or benefit if:
- (a) the other property or benefit was not reasonably capable of identification when the application for the order was originally made; or
 - (b) necessary evidence became available only after that application was originally made.
- (2) Where:
- (a) the Secretary for Justice applies to amend an application for a forfeiture order; and
 - (b) the effect of the amendment would be to include additional property in the application for the forfeiture order,
- the Secretary for Justice shall give reasonable written notice of the application to amend to any person whom the Secretary for Justice has reason for believing may have an interest in the additional property.
- (3) Any person who claims an interest in the additional property, may appear and adduce evidence at the hearing of the application to amend.
- (4) Where:
- (a) the Secretary for Justice applies to amend an application for a pecuniary penalty order against a person; and
 - (b) the effect of the amendment would be to include an additional benefit in the application for the pecuniary penalty order,
- the Secretary for Justice shall give the person reasonable written notice of the application to amend.

14 Procedure on application

On an application to the court made under Section 11, the court may:

- (a) in determining the application, take into account the transcript of any proceedings against the person for the offence; or
- (b) defer passing sentence until the court has determined the application if the court:
 - (i) has not, when the application is made, passed sentence on the person for an offence because of which the property became tainted; and

- (ii) it is satisfied that it is reasonable to do so in all the circumstances.

15 Application for forfeiture order if person has absconded

- (1) Where, in connection with a serious offence committed after this Act commences:
- (a) an information has been laid alleging that a person committed the offence;
 - (b) a warrant for the person's arrest is issued for that information; and
 - (c) the person absconds,
- the Secretary for Justice may, within 6 months after the person absconds, apply to the court for a forfeiture order for any tainted property.
- (2) For the purposes of this Section:
- (a) a person is taken to have absconded in connection with an offence if reasonable attempts to arrest the person under a warrant have been unsuccessful during the 6 months starting on the day that the warrant was issued; and
 - (b) the person is taken to have absconded on the last day of that 6 months.
- (3) Where the Secretary for Justice applies, under subsection (1), for a forfeiture order against property, the court shall, before hearing the application, require:
- (a) reasonable written notice of the application to be given to any person who, in the opinion of the court, appears to have an interest in the property; or
 - (b) notice of the application, containing the particulars that the court directs, to be published as often as the court directs, in the Government Gazette.
- (4) A forfeiture order under this Section, may be made even if the person against whom the warrant is issued dies after the issue of the warrant.

DIVISION 2 — FORFEITURE ORDERS FOR TAINTED PROPERTY UPON CONVICTION [Div 2 heading subst Act 4 of 2023 s 7, opn 7 June 2023]

16 Nauruan land is excluded from forfeiture order

A forfeiture order shall not be made against any piece of land in the Republic.

17 Forfeiture order on conviction

- (1) Where:
- (a) the Secretary for Justice applies to the court for a forfeiture order against tainted property in relation to a person's conviction of a serious offence; and
 - (b) the court is satisfied that the property is tainted property in relation to that offence, the court may order that the property, or so much of the property as is specified by the court in the order, be forfeited to the Republic.
- (2) In deciding whether property is tainted property, the court may infer:
- (a) if the evidence establishes that the property was in the person's possession or effective control at the time of, or immediately after, the offence was committed, that the property was used in, or in connection with, committing the offence;

- (b) if the evidence establishes that the property was found, during investigations by the police before or after the person was arrested for, and charged with, the offence:
 - (i) in the person's possession; or
 - (ii) under the person's control in a building, vehicle, receptacle or place, that the property was derived, obtained or realised as a result of the person's committing the offence; and
 - (c) if:
 - (i) the evidence establishes that the value, after the person committed the offence, of all the person's ascertainable property is more than the value of all the person's ascertainable property before the person committed the offence; and
 - (ii) the court is satisfied that the person's income from sources unrelated to criminal activity cannot reasonably account for the increase in value, that the value of the increase represents property that the person derived, obtained or realised directly or indirectly from committing the offence.
- (2A) The Supreme Court may infer in the absence of evidence to the contrary that:
- (a) such property had been intended for use in, or had been used in or in connection with, the commission of a serious offence if it had been in the person's possession at the time of, or immediately after, the commission of the serious offence for which the person was convicted; or
 - (b) the property was derived, obtained or realised as a result of the commission of the serious offence if it was acquired by the person before, during or within a reasonable time after the period of the commission of the serious offence for which the person was convicted.
- [subs (2A) insrt Act 4 of 2023 s 8, opn 7 June 2023]
- (3) Where the court orders that property, other than money, be forfeited to the Republic, the court shall specify in the order the amount that it considers to be the value of the property when the order is made.
 - (4) In considering whether to make a forfeiture order against property, the court may take into account:
 - (a) any right or interest of a third party in the property;
 - (b) the gravity of the offence concerned;
 - (c) any hardship that may reasonably be expected to be caused to any person by the operation of the order; and
 - (d) the use that is ordinarily made of the property, or the use to which the property was intended to be put.
 - (5) Where the court makes a forfeiture order, the court may give any directions that are necessary or convenient to give effect to the order.

18 Voiding of contract

A court may, before making a forfeiture order under Section 17, set aside any conveyance or transfer of property that occurred after the seizure of the property or service of the notice of application on persons affected by the order under Section 12, unless the transfer was for valuable consideration to a person acting in good faith and without notice.

19 Effect of forfeiture order

- (1) Where the court makes a forfeiture order against property, the order vests the property absolutely in the Republic.
- (2) Where the court makes a forfeiture order against property:
 - (a) the property shall not, except with the leave of the court and in accordance with any directions of the court, be disposed of, or otherwise dealt with, by or for the Republic, before:
 - (i) any appeal against the conviction, or the making of the order, is finally determined, or lapses; or
 - (ii) the last day allowed for the lodging of an appeal against the conviction or order passes without an appeal having been lodged; and
 - (b) the property may be disposed of, and the proceeds applied or otherwise dealt with as the Administrator directs, after:
 - (i) the determination or lapsing of any appeal lodged against the conviction or the making of the order; or
 - (ii) the last day allowed for lodging an appeal is past without an appeal having been lodged.

20 Protection of third parties

- (1) Where an application is made for a forfeiture order against property, a person who claims an interest in the property, may apply to the court, before the forfeiture order is made, for an order under subsection (2).
 - (2) Where a person applies to the court for an order in respect of that person's interest in the property, the court shall make an order declaring the nature, extent and value, as at the time the order is made, of the person's interest if the court is satisfied:
 - (a) that the applicant was not in any way involved in committing an offence for which forfeiture of the property is sought, or a forfeiture order against the property was made; and
 - (b) if the applicant acquired the interest at the time of, or after, the offence was committed:
 - (i) for sufficient consideration; and
 - (ii) without knowing, and in circumstances so as not to arouse a reasonable suspicion, that the property was, at the time of the acquisition, tainted property.
 - (3) Where a forfeiture order has already been made against property, a person who claims an interest in the property may, within 12 months starting on the day when the order is made, apply to the court for an order under subsection (2).

- (4) A person may not make an application under subsection (3), except with the leave of the court, if the person:
 - (a) knew about the application for the forfeiture order before the order was made; or
 - (b) appeared at the hearing of that application.
 - (5) A person who applies to the court under subsection (1) or (3) shall give notice within 14 days of the application to the Secretary for Justice.

- (6) The Secretary for Justice:
 - (a) is a party to the proceedings in an application under subsection (1) or (3); and
 - (b) may make an application under subsection (1) for a person.
- (7) An appeal lies to the Supreme Court from an order made under subsection (2).
- (8) On application by a person who has obtained an order under subsection (2), if the period allowed for appeals has expired and any appeal from that order has been determined or has lapsed, the Administrator shall:
 - (a) return the property, or the part of it to which the interest of the applicant relates, to the applicant; or
 - (b) pay an amount equal to the value of the interest of the applicant, as declared in the order, to the applicant.

21 Forfeiture order where person has absconded

- (1) This Section applies if:
 - (a) an application is made to the court for a forfeiture order against property; and
 - (b) the court is satisfied that:
 - (i) any property is tainted property;
 - (ii) proceedings for a serious offence committed for that property were commenced; and
 - (iii) the accused charged with the offence commenced under subparagraph (ii) has absconded.
- (2) Where a person:
 - (a) is taken to have absconded in connection with an offence; or
 - (b) is dead,the Court may order that the property or part of it as the Court specifies in the order, be forfeited to the Republic.
[subs (2) subst Act 4 of 2023 s 10, opn 7 June 2023]
- (3) Section 28 except subsection (1), and Sections 29 and 30 apply, with any necessary modifications, to an order under this Section.

22 Discharge of forfeiture order on appeal or quashing of conviction

- (1) Where the court makes a forfeiture order against property in reliance on a person's conviction of a serious offence and the conviction is subsequently quashed, the quashing of the conviction discharges the order.
- (2) Where a forfeiture order against property is discharged:
 - (a) under subsection (1); or
 - (b) by the court hearing an appeal against the making of the order, a person who claims to have had an interest in the property immediately before the forfeiture order was made, may apply to the Administrator, in writing, for the transfer of the interest to the person.
- (3) On receipt of an application under subsection (2) from a person who had an interest in the property, the Administrator shall:
 - (a) if the interest is vested in the Republic, transfer the property or interest in the property, or the part of it to which the interest relates, to the person; or

- (b) if the Republic has disposed of the interest, and subject to subsection (5), pay the person an amount equal to the value of the interest at the time the order is made.
- (4) The Administrator:
 - (a) may ask the court to determine whether the person had the interest claimed under subsection (2); and
 - (b) has power to do, or authorise the doing of, anything necessary or convenient to transfer or return property, including executing any instrument.
- (5) Where, on an application made under Section 20 in respect of any interest in property, the court has made an order under that Section declaring that there is payable by the Republic to the applicant an amount equal to the value of the interest declared by the court, an amount equal to that amount shall be deducted from any amount required to be paid, under subsection (3)(b), to that applicant in respect of that interest.

23 Payment instead of forfeiture order

Where the court is satisfied that a forfeiture order should be made against property of a person, but that the property, or any part of it or interest in it, cannot be made subject to that order, and:

- (a) cannot, with the exercise of due diligence, be found;
 - (b) has been transferred to a third party in circumstances that do not give rise to a reasonable inference that the title or interest was transferred to avoid the forfeiture of the property;
 - (c) is located outside the Republic;
 - (d) has been mingled with other property that cannot be divided without difficulty; or
 - (e) has been substantially diminished in value or rendered worthless,
- the court may, instead of ordering the property, part or interest to be forfeited, order the person to pay to the Republic an amount equal to the value of the property, part or interest.

24 Enforcement of order for payment instead of forfeiture

- (1) An amount payable by a person to the Republic under an order made under Section 23 is a civil debt due by the person to the Republic.
- (2) An order against a person made under Section 23 may be enforced as if it were an order made in civil proceedings instituted by the Republic against the person to recover a debt due by the person to the Republic, and the debt arising from the order is taken to be a judgment debt.

25 Registered foreign forfeiture orders

Where a foreign forfeiture order is registered in the court under the *Mutual Assistance in Criminal Matters Act*, Sections 17, 18, 19, 20, 21, 22, 23 and 24 apply to the order as if:

- (a) the order were a forfeiture order made by the court under this Act;
- (b) references to an appeal against the making of an order were omitted; and
- (c) the period mentioned in Section 20(3) were 6 weeks rather than 12 months.

DIVISION 2A — FORFEITURE OF RESTRAINED PROPERTY UPON CONVICTION OF
SERIOUS OFFENCE

25A Forfeiting restrained property without a forfeiture order where a person has been convicted of serious offence

- (1) The Supreme Court shall order that property be forfeited to the Republic at the end of the period applying under subsection (3) where:
 - (a) a person is convicted of a serious offence;
 - (b) either:
 - (i) at the end of that period, the property is covered by a restraining order under Division 3 of Part 3 against the person that relates to the offence; or
 - (ii) the property was covered by such a restraining order against the person, but the order was revoked under Section 57; and
 - (c) the property is not subject to an order under Section 53(3) or 66(3) excluding the property from forfeiture under this Part.
- (2) This Section applies notwithstanding that:
 - (a) the restraining order was made before or after the person's conviction of serious offence; or
 - (b) immediately before forfeiture, the property is the person's property or another person's property.
- (3) The period at the end of which the property shall be forfeited is the 6-month period commencing on the day a person is convicted of a serious offence.

25B Notice of date of forfeiture under this Part

- (1) The Secretary for Justice in relation to the restraining order referred to in Section 25A(1) shall, before property is forfeited under this Part, take reasonable steps to give any person who has or claims to have, or who the Secretary for Justice reasonably believes may have, an interest in the property a written notice stating:
 - (a) the date on which the property shall be forfeited under this Part unless it is excluded from forfeiture;
 - (b) the effect of Section 25C; and
 - (c) that the person may be able to apply for an order under one of the following Sections in relation to the property:
 - (i) Section 25C;
 - (ii) Section 25E; or
 - (iii) Section 53(3).
- (2) The Secretary for Justice is not required to give a notice to a person if the person has made:
 - (a) an application for an extension order in relation to the property; and
 - (b) an application under Section 25D, 53(3) or 66(3) in relation to the property.

25C Making an extension order extending the period before property is forfeited

- (1) The Supreme Court may in relation to an order made under Section 25A(1) make an order extending the period under Section 25A(3) where:

- (a) an application for the order is made before the period under Section 25A(3) lapses;
 - (b) the applicant has also applied to the Court under:
 - (i) Section 53(3) or 66(3) to exclude property from the restraining order; or
 - (ii) Section 25D to exclude the property that is covered by the restraining order from forfeiture under this Part; and
 - (c) the Court is satisfied that the applicant made the application under Section 25D, 53(3) or 66(3) within 14 days of having acquired or with reasonable diligence ought to have acquired the knowledge.
- (2) The extended period that is specified shall end no later than 12 months from the day a person is convicted of the serious offence.
 - (3) The extension order stops being in force where the application under Section 25D, 53(3) or 66(3) is determined before the end of the:
 - (a) 6-month period referred to in Section 25A(3); or
 - (b) specified extended period.
 - (4) Where the Supreme Court makes the extension order, the Secretary for Justice shall take reasonable steps to give any person who has or claims to have, or whom the Secretary for Justice reasonably believes may have, an interest in the property to which the order relates, a written notice stating:
 - (a) the date on which the property shall be forfeited under this Part, in accordance with the extension order, unless it is excluded from forfeiture; and
 - (b) the effect of subsections (2) and (3).

25D Excluding property from forfeiture under this Part

- (1) The Supreme Court shall, in relation to an order referred to in Section 25A(1), make an order excluding particular property from forfeiture under this Part where:
 - (a) a person applies for an order under this Section;
 - (b) the Court is satisfied that the person who applied has an interest in property covered by the restraining order;
 - (c) another person has been convicted of a serious offence to which the restraining order relates;
 - (d) the Court is satisfied that the interest of the person who made the application, in the property, is neither proceeds of the serious offence nor an instrument of the serious offence; and
 - (e) the Court is satisfied that the interest of the person who applied in the property was lawfully acquired.
- (2) An order under this Section cannot be made in relation to property if the property has already been forfeited under this Part.
- (3) The person shall give written notice to the Secretary for Justice of both the application and the grounds on which the order is sought.
- (4) The Secretary for Justice may appear and adduce evidence at the hearing of the application.
- (5) Subject to subsection (6), the Secretary for Justice shall give the applicant notice of any grounds on which the Director proposes to contest the application.

- (6) The notice required under subsection (5) shall be given by the Secretary for Justice within 14 days of receiving the application.

25E Compensating for proportion of property not derived or realised from commission of any offence

- (1) The Supreme Court in relation to a restraining order referred to in Section 25A(1) shall, make an order that complies with subsection (2) where:
- (a) a person has applied for an order under this Section;
 - (b) the Court is satisfied that such person has an interest in property covered or that was at any time covered, by the restraining order;
 - (c) another person has been convicted of a serious offence to which the restraining order relates;
 - (d) the Court is satisfied that a proportion of the value of such person's interest was not derived or realised, directly or indirectly, from the commission of any offence; and
 - (e) the Court is satisfied that such person's interest is not an instrument of any offence.
- (2) An order under this Section shall:
- (a) specify the proportion found by the Supreme Court under subsection (1)(d); and
 - (b) direct the Republic, once the property has vested absolutely in it, to:
 - (i) where the property has not been disposed of — dispose of the property; and
 - (ii) pay such person an amount equal to that proportion of the difference between the amount received from disposing of the property and the sum of any payments of the kind referred to in Section 100(4)(e) in connection with the forfeiture.
- (3) Subject to subsection (4), an application under this Section may be made at any time.
- (4) The Supreme Court may give the person leave to apply where the Court is satisfied that:
- (a) the person had:
 - (i) been given a notice under Section 25C(1) in relation to the property; or
 - (ii) not been given such a notice for the purposes of Section 25B(2);
 - (b) the person did not make the application under subsection (3) before such forfeiture;
 - (c) the person had a good reason for not making the application before the forfeiture; or
 - (d) the person now has evidence relevant to the application that was not available before the forfeiture.
- (5) The person shall give written notice to the Secretary for Justice of both the application and the grounds on which the order is sought.
- (6) The Secretary for Justice may appear and adduce evidence at the hearing of the application.
- (7) Subject to subsection (9), the Secretary for Justice shall give the applicant notice of any grounds on which the Secretary proposes to contest the application.

- (8) The notice required under subsection (7) shall be given after the Secretary for Justice has had a reasonable opportunity to conduct examinations in relation to the application.
- (9) The application shall not be heard until the Secretary for Justice has had a reasonable opportunity to conduct examinations in relation to the application.

DIVISION 3 — PECUNIARY PENALTY ORDERS

26 Pecuniary penalty order on conviction

- (1) Where the Secretary for Justice applies to the court for a pecuniary penalty order against a person for the person's conviction of a serious offence, the court may, if it is satisfied that the person has benefited from the offence, order the person to pay to the Republic:
 - (a) an amount equal to the value of the person's benefit from the offence; or
 - (b) a lesser amount that the court certifies to be the amount that might be realised at the time the pecuniary penalty order is made.
- (2) The court shall assess the value of the benefit derived by a person from committing an offence in accordance with Sections 29, 30, 31, 32 and 33.
- (3) The court shall not make a pecuniary penalty order under this Section:
 - (a) until the period for the lodging of an appeal against conviction has expired without an appeal having been lodged; or
 - (b) if an appeal against conviction has been lodged, until the appeal lapses or is finally determined.

27 Rules for determining benefit and assessing value

- (1) Where a person obtains tainted property, the person's benefit is the value of the property so obtained.
- (2) Where a person derives an advantage as the result of, or in connection with committing, a serious offence, the person's advantage is taken to be a sum of money equal to the value of the advantage so derived.
- (3) Unless the contrary is proved:
 - (a) property is taken to be tainted property if it is held by a person:
 - (i) on the day when the application is made; and
 - (ii) at any time:
 - (A) if the offence or earliest offence was committed more than 5 years before the application is made, within 5 years before the application is made; and
 - (B) in any other case, after the offence, or the earliest offence, was committed and before the application is made; and
 - (b) any expenditure by the person in the time in subparagraph (a)(ii) is taken to be expenditure met out of tainted property;
 - (c) any property received or taken to have been received by the person at any time as a result of, or in connection with, committing the offence or offences is taken to have been received free of any other interests; and
 - (d) if evidence is given at the hearing of the application that the value of the person's property increased after committing an offence, the increase is taken to be part of the person's benefit from the offence.

- (4) Where a pecuniary penalty order has previously been made against a person in relation to an offence, any of the person's benefits that are shown to the court to have been taken into account in determining the amount to be recovered under the earlier order shall be disregarded.
- (5) Where evidence is given at the hearing of the application that the value of the person's property at any time after the commission of the serious offence exceeded the value of the person's property before the commission of the offence, then the Supreme Court shall, subject to subsection (6) treat the value of the benefit as being not less than the amount of that excess.

- (6) Where, after evidence of the kind referred to in subsection (5) is given, the person satisfies the Supreme Court that the whole or part of the excess was due to causes unrelated to the commission of the serious offence, subsection (5) does not apply to the excess or that part.

- (7) For the purposes of this Section:

- (a) *'tainted property'* includes property that is held by a person but under the effective control of another person; and
- (b) *'derives an advantage'* includes reducing or avoiding a cost or loss.

[subs (7) insrt Act 4 of 2023 s 13, opn 7 June 2023]

28 Statements about benefits from committing serious offences

- (1) Where a person has been convicted of a serious offence, the Secretary for Justice may tender to the court a statement about any matter relevant to:
- (a) deciding whether the person has benefited from the offence or from any other serious offence of which the person is convicted in the same proceedings or that is taken into account in passing sentence on the person; or
- (b) assessing the value of the person's benefit from the offence or any other serious offence of which the person is so convicted in the same proceedings or that is so taken into account.
- (2) Where the court is satisfied that a copy of the statement has been served on the person, the court may require the person to indicate:
- (a) to what extent the person accepts each allegation in the statement; and
- (b) for each allegation that the person does not accept wholly or in part, any matters that the person proposes to rely on.
- (3) Where the person accepts to any extent an allegation in the statement, the court may, in deciding or assessing the matters mentioned in subsection (1), treat the person's acceptance as conclusive of the matters to which it relates.
- (3A) Where:
- (a) the person tenders to the Supreme Court a statement as to any matters relevant to determining the amount that might be realised at the time the pecuniary penalty order is made; and
- (b) the Secretary for Justice accepts to any extent any allegation in the statement,
- the Supreme Court may, for the purposes of that determination, treat the acceptance of the Secretary for Justice as conclusive of the matters to which it relates.

[subs (3A) insrt Act 4 of 2023 s 14, opn 7 June 2023]

- (4) In this Section, if a person fails, wholly or in part, to comply with a requirement under subsection (2), the court may treat the person as having accepted every allegation in the statement, other than:
 - (a) an allegation for which the person has complied with the requirement; or
 - (b) an allegation that the person has benefited from the offence concerned, or that the person obtained any property or advantage as a result of, or in connection with, committing the offence.
- (5) In this Section, an allegation may be accepted, or matter indicated, either:
 - (a) orally before the court; or
 - (b) in writing.
- (6) An acceptance by a person under this Section that the person received any benefits from committing a serious offence is admissible in any proceedings against the person for any offence.

29 Amount to be recovered under pecuniary penalty order

- (1) The amount to be recovered from a person under a pecuniary penalty order is the amount that the court assesses to be the value of the person's benefit from the offence, or all the offences, concerned.
- (2) Where the court is satisfied, whether by an acceptance under Section 28 or otherwise, about a matter relevant to determining the amount that might be realised at the time a pecuniary penalty order is made, the court may issue a certificate giving the court's opinion about the matter.
- (3) The court shall issue the certificate if it is satisfied that the amount that might be realised at the time the pecuniary penalty order is made is less than the amount that the court assesses to be the value of the person's benefit from the offence, or all the offences, for which the pecuniary penalty order may be made.

30 Working out how much is realisable

- (1) For the purposes of Sections 28 and 29, the amount that might be realised at the time a pecuniary penalty order is made against a person is the total of:
 - (a) the values at that time of all the realisable property held by the person, less the total amounts payable under any obligation having priority at that time; and
 - (b) the total of the values at that time of all gifts caught by this Act.
- (2) For the purposes of subsection (1), an obligation of a person has priority at a time if it is an obligation to:
 - (a) pay a fine, or an amount due under an order of the court imposed or made on conviction of an offence, if the fine was imposed or the order made before the pecuniary penalty order; or
 - (b) pay any other civil obligation as may be determined by the court.

31 Variation of pecuniary penalty orders

- (1) Where:
 - (a) the court makes a pecuniary penalty order in relation to an offence;

- (b) in calculating the amount of the pecuniary penalty order, the court took into account a forfeiture of property or a proposed forfeiture of property or a proposed forfeiture order against property; and
 - (c) an appeal against the forfeiture or forfeiture order is allowed, or the proceedings for the proposed forfeiture order terminate without the proposed order being made, the Secretary for Justice may apply to the court to vary the pecuniary penalty order to increase the amount of the order by the value of the property, and the court may, if it considers it appropriate to do so, vary the order accordingly.
- (2) Where:
- (a) the court makes a pecuniary penalty order against a person in relation to an offence;
 - (b) in calculating the amount of the pecuniary penalty order, the court took into account an amount of tax paid by the person; and
 - (c) an amount is repaid or refunded to the person for that tax, the Secretary for Justice may apply to the court to vary the pecuniary penalty order to increase the amount of the order by the amount repaid or refunded, and the court may, if it considers it appropriate to do so, vary the order accordingly.

32 Court may lift corporate veil

- (1) In assessing the value of benefits derived by a person from committing a serious offence, the court may treat as the person's property any property that, in the opinion of the court, is under the person's effective control, whether or not the person has:
 - (a) any legal or equitable interest in the property; or
 - (b) any right, power or privilege in connection with the property.
- (2) Without limiting subsection (1), the court may take into account:
 - (a) shareholdings in, debentures over, or directorships of, a corporation that has an interest, whether direct or indirect, in the property;
 - (b) a trust that has a relationship to the property; and
 - (c) any relationship between persons having an interest in the property, or in corporations of the kind in paragraph (a) or trusts of the kind in paragraph (b), and other persons.
- (3) For the purpose of subsection (2)(a), to decide whether a particular corporation has a direct or indirect interest in property, the court may order the investigation and inspection of the books of the corporation.
- (4) Where the court, in making a pecuniary penalty order against a person, treats particular property as the person's property under subsection (1), the court may, on application by the Secretary for Justice, make an order declaring that the property is available to satisfy the order.
- (5) Where the court declares that property is available to satisfy a pecuniary penalty order:
 - (a) the order may be enforced against the property as if the property were property of the person against whom the order is made; and
 - (b) a restraining order may be made for the property as if the property were property of the person against whom the order is made.
- (6) Where the Secretary for Justice applies for an order that property is available to satisfy a pecuniary penalty order against a person:
 - (a) the Secretary for Justice shall give reasonable written notice of the

application to the person and to any other person who the Secretary for Justice has reason for believing may have an interest in the property; and

- (b) the person and any other person who claims an interest in the property may appear and adduce evidence at the hearing of the application.

33 Enforcement of pecuniary penalty orders

- (1) An amount payable by a person to the Republic under a pecuniary penalty order is a civil debt due by the person to the Republic.
- (2) A pecuniary penalty order against a person may be enforced as if it were an order made in civil proceedings instituted by the Republic against the person to recover a debt due by the person to the Republic and the debt arising from the order is taken to be a judgment debt.

34 Discharge of pecuniary penalty order

A pecuniary penalty order is discharged:

- (a) where the conviction of the serious offence or activities in reliance on which the order was made is or is taken to be quashed and no conviction for the serious offence or activities is substituted;
- (b) where the order is quashed; or
- (c) on the satisfaction of the order by payment of the amount due under the order in accordance with any written law.

**PART 3 — FACILITATING INVESTIGATIONS AND PRESERVING
PROPERTY**

DIVISION 1 — POWERS OF SEARCH AND SEIZURE

35 Warrant to search land for tainted property

- (1) Where a police officer has reasonable grounds for suspecting that there is or may be, tainted property of a particular kind:
 - (a) on a person;
 - (b) otherwise than in a person's immediate power or control; or
 - (c) upon land or any building on such land,the police officer may file before a Resident Magistrate information on oath setting out those grounds and apply for the issue of a warrant to search the person, the land or the building.
- (2) Where an application is made for a warrant to search a person or the land the Resident Magistrate may subject to subsection (3) issue a warrant authorising a police officer, with such assistance and by such force as is necessary and reasonable:
 - (a) to search the person for property of that kind;
 - (b) to enter upon the land or in or upon any premises and to search the land or premises for property of that kind; and
 - (c) to seize property found in the course of the search that the police officer believes on reasonable grounds to be property of that kind.
- (3) The warrant shall state:
 - (a) the purpose for which it is issued including, in respect of tainted property, a reference to the nature of the relevant serious offence;
 - (b) a description of the kind of property authorised to be seized;
 - (c) a time at which the warrant ceases to be in force; and
 - (d) whether entry is authorised to be made at any time of the day or night or during specified hours.
- (4) Where during the course of searching under the warrant, a police officer finds:
 - (a) property that the police officer believes on reasonable grounds to be tainted property of a type not specified in the warrant or tainted property in relation to other serious offences; or
 - (b) any property the police officer believes on reasonable grounds will serve as evidence as to the commission of a serious offence,the police officer may seize that property.
- (5) Where by reason of urgency a police officer considers it necessary to do so, he or she may make application for a search warrant under Section 35A by telephone or by other means of communication and:
 - (a) a Resident Magistrate to whom an application for the issue of a warrant is made by telephone or other means of communication may sign a warrant where he or she is satisfied that it is necessary to do so;
 - (b) the Resident Magistrate granting the search warrant shall inform the police officer of the terms of the warrant so signed and the police officer shall complete a form of warrant in the terms furnished by the Resident Magistrate; and

- (c) the police officer to whom a warrant is granted by telephone or other means of communication shall, no later than the next working day following the execution of the warrant give the Resident Magistrate a duly sworn information and the form of warrant completed by the police officer.

35A Search and seizure without warrant

- (1) A police officer may:
- (a) search a person for tainted property;
 - (b) enter upon land or upon or into premises and search the land or premises for tainted property; and
 - (c) in the exercise of power under subsections (a) and (b), seize any property found in the course of the search that the police officer believes on reasonable grounds to be tainted property.
- (2) Any search or seizure under subsection (1)(a), (b) or (c) shall be made with the consent of the person or the occupier of the land or premises or a warrant issued under Section 35.
- (3) Where a police officer may search a person under this Part, he or she may also search any property in the immediate power or control of the person.

36 Police may seize any tainted property not included in the warrant

- (1) Where, in the course of a search under a warrant issued under Section 35 for a thing of a kind specified in the warrant, a police officer finds another thing, the warrant is taken to authorise the police officer to seize the other thing if that officer has reasonable grounds:
- (a) for believing the other thing to be tainted property or to afford evidence about the commission or a serious offence in the Republic; or
 - (b) for believing that it is necessary to seize the property or thing to prevent it being concealed, lost or destroyed, or used to commit, continue or repeat the offence or another offence.
- (2) All property seized under this Section is held by the Commissioner.

36A Duty of police officer seizing property

A police officer who seizes property under this Part shall:

- (a) detain the property seized;
- (b) make a written inventory of the properties seized;
- (c) where possible, require the person who has the power or control to countersign the inventory to verify the accuracy of the property seized; and
- (d) take reasonable care to ensure that the property is preserved or secured.

37 Return of seized property general rule

- (1) Where property has been seized under Section 36, a person who claims an interest in the property may apply to the court for an order that the property be returned to the person.

- (2) Subject to subsection (3), the court shall order the Commissioner to return the property to the person if the court is satisfied that:
- (a) the person is entitled to possession of the property;
 - (b) the property is not tainted property; and
 - (c) the person for whose conviction, charging or proposed charging the property was seized has no interest in the property.

 - (c) an information is not laid for an offence for which the property is tainted within 28 days after the property was seized.

39 Return of seized property if no forfeiture order made

- (1) Subsection (2) applies if:
- (a) property has been seized under Section 36;
 - (b) no forfeiture order is made against the property within 28 days after it was seized; and
 - (c) the property is in the Commissioner's possession at the end of that period.

- (2) The Commissioner shall arrange for the property to be returned to the person from whose possession it was seized as soon as practicable after the end of that period.

40 Retention of seized property if restraining order made

- (1) Subsections (2), (3) and (4) apply if:
- (a) property has been seized under Section 36;
 - (b) a restraining order is made against the property before the Commissioner is required by this Act to return it; and
 - (c) the restraining order directs the Administrator to take custody and control of the property.
- (2) Notwithstanding Section 38 or 39, the Commissioner shall arrange for the property to be given to the Administrator in accordance with the restraining order.
- (3) Where, when the restraining order is made, the property is in the

Commissioner's possession, the Commissioner may apply to the court for an order that the Commissioner keep possession of the property.

- (4) Where the court is satisfied that there are reasonable grounds for believing that the property may afford evidence as to the commission of an offence, the court may order that the Commissioner retain the property for as long as the property is so required as evidence.
- (5) Where the court makes an order under subsection (4) about the property, the Commissioner shall arrange for the property to be retained until it is dealt with in accordance with another provision of this Act.
- (6) In proceedings for an order under subsection (4), the court may order that a witness need not:
 - (a) answer a specified question; or
 - (b) produce a specified document,if the court is satisfied that answering the question or producing the document may prejudice the investigation of, or the prosecution of a person for, an offence.

41 How the Commissioner shall deal with property subject to forfeiture order

- (1) Subsection (2) applies if:
 - (a) property has been seized under this Act; and
 - (b) while the property is in the Commissioner's possession, a forfeiture order is made against the property.
- (2) The Commissioner shall deal with the property as required by the order.

DIVISION 2 — SEARCH FOR AND SEIZURE OF TAINTED PROPERTY-FOREIGN SERIOUS OFFENCES

42 Application of Sections 43 to 47

- (1) Where, under the *Mutual Assistance in Criminal Matters Act*, a police officer is authorised to apply to the Court, for a search warrant for tainted property, Sections 43 to 47 apply to:
 - (a) the application; and
 - (b) any warrant issued as a result of the application.
- (2) In this Section and in Sections 43 to 47:
 - (a) references to tainted property are taken to be references to tainted property in relation to a foreign serious offence; and
 - (b) references to a relevant offence are taken to be references to a relevant foreign serious offence.

43 Police may seize tainted property

- (1) Subsection (2) applies if, in the course of searching under a warrant mentioned in Section 42 for tainted property, a police officer finds:
 - (a) property that there are reasonable grounds for believing is tainted property for which another search warrant under that Section is in force; or
 - (b) anything that there are reasonable grounds to believe:
 - (i) is relevant to a criminal proceeding in the foreign country for the foreign serious offence; or

- (ii) will afford evidence as to the commission of a relevant offence.
- (2) Where there are reasonable grounds for believing that it is necessary to seize the property or thing in order to prevent its concealment, loss or destruction, or its use in committing, continuing or repeating the relevant offence, the warrant is taken to authorise the police officer to seize the property or thing.

44 Return of seized property-general rule

- (1) Where property has been seized under Section 43(2), a person who claims an interest in the property, may apply to the court for an order that the property be returned to the person.
- (2) Subject to subsection (3) court shall order the Commissioner to return the property to the person if the court is satisfied that:
 - (a) the person is entitled to possession of the property
 - (b) the property is not tainted property; and
 - (c) the person who is believed or alleged to have committed the relevant offence has no interest in the property.

 - (a) property has been seized under Section 43(2);
 - (b) no forfeiture order is made against the property within 30 days after it was seized; and
 - (c) the property is in the Commissioner's possession at the end of that period.
- (2) The Commissioner shall arrange for the property to be returned to the person from whose possession it was seized as soon as practicable after the end of that period.

46 Retention of seized property if restraining order made

- (1) Subsections (2), (3) and (4) apply if:
 - (a) property has been seized under Section 43(2);
 - (b) but, for that subsection, the Commissioner would be required to arrange for the property to be returned to a person as soon as practicable after the end of a period; and
 - (c) before the end of that period:
 - (i) a foreign restraining order against the property is registered in the court; or
 - (ii) the court makes a restraining order in respect of the relevant offence against the property.
- (2) The Commissioner shall:
 - (a) if the restraining order directs the Administrator to take custody and control of the property, arrange for the property to be given to the Administrator in accordance with the restraining order; or

- (b) if the court has made an order under subsection (4) about the property, arrange for the property to be retained until it is dealt with in accordance with another provision of this Act.
- (3) Where the property is in the Commissioner's possession when the restraining order is made or registered, the Commissioner may apply to the court for an order that the Commissioner retain possession of the property.
- (4) The court may, if satisfied that there are reasonable grounds for believing that the property may afford evidence as to the commission of a relevant offence, order that the Commissioner may retain the property for as long as the property is so required as evidence.
- (5) In proceedings for an order under subsection (4), the court may order that a witness need not:
 - (a) answer a specified question; or
 - (b) produce a specified document,
 if the court is satisfied that answering the question, or producing the document, may prejudice the investigation of, or the prosecution of a person for, an offence.

47 **How Commissioner shall deal with property subject to forfeiture order**

- (1) Subsection (2) applies if:
 - (a) property has been seized under this Act; and
 - (b) while the property is in the Commissioner's possession, a foreign forfeiture order against the property is registered in the court.
- (2) The Commissioner shall deal with the property as required by the order.

DIVISION 3 — RESTRAINING ORDERS

48 **Restraining order**

- (1) The Secretary for Justice may apply to the Supreme Court for a restraining order against:
 - (a) any tainted property held by a person charged or convicted of a serious offence; or
 - (b) any specified tainted property held by a person other than the person convicted of a serious offence.
- (2) An application for a restraining order under subsection (1)(a) or (b) may be made *ex parte* and shall be in writing and be accompanied by an affidavit stating:
 - (a) where the person has been convicted of a serious offence, the serious offence for which he or she was convicted, the date of the conviction, the court before which the conviction was obtained and whether an appeal has been lodged against the conviction;
 - (b) where the person has not been convicted of a serious offence, for which he or she is charged, the grounds for believing that he or she committed such serious offence;
 - (c) a description of the tainted property in respect of which the restraining order is sought;
 - (d) the name and address of the person who is believed to be in possession of the tainted property;

- (e) the grounds for the belief that the property is tainted property in relation to the offence or that the person derived a benefit directly or indirectly from the commission of the offence;
 - (f) where the application seeks a restraining order against property of a person other than the person suspected of committing the serious offence, the grounds for the belief that the property is tainted property in relation to the offence and is subject to the effective control of the person suspected of committing the serious offence; and
 - (g) the grounds for the belief that a forfeiture order may be or is likely to be made under this Act in respect of the tainted property.
- (3) An application for a restraining order under subsection (1) for tainted property that is terrorist property may be made *ex parte* and shall be in writing and be accompanied by an affidavit stating:
- (a) a description of the property in respect of which the restraining order is sought;
 - (b) the name and address of the person who is believed to be in possession of the property;
 - (c) that the property is terrorist property or believed to be; and
 - (d) the grounds for the belief that a forfeiture order may be or is likely to be made under this Act in respect of the property.

50 Restraining order

- (1) The court may make a restraining order against property if it is satisfied that:
- (a) the defendant has been convicted of a serious offence, or has been charged or is about to be charged with a serious offence;
 - (b) where the defendant has not been convicted of a serious offence, there are reasonable grounds for believing that the defendant committed the serious offence;
 - (c) there are reasonable grounds to believe that the property is tainted property in relation to a serious offence or that the defendant derived a benefit directly or indirectly from the commission of the serious offence;
 - (d) where the application seeks a restraining order against property of a person other than the person suspected of committing a serious offence, there are reasonable grounds for believing that the property is tainted property in relation to an offence and that the property is subject to the effective control of the person suspected of committing the serious offence; and
 - (e) there are reasonable grounds for believing that a forfeiture order may be or is likely to be made under this Act in respect of the property.

- (2) The order may:
- (a) prohibit the defendant or any other person from disposing of, or otherwise dealing with, the property, or a part of it or interest in it specified in the order, either absolutely or except in a way specified in the order; and

- (b) at the request of the Secretary for Justice, if the court is satisfied that the circumstances so require, direct the Administrator:
- (i) to take custody of the property or a part of it specified in the order; and
 - (ii) to manage or otherwise deal with all, or any part of, the property in accordance with the directions of the court.
- (2A) Where the Administrator is given a direction in relation to any property, he or she may apply to the Supreme Court for directions on any question relating to the management or preservation of the property under his or her control.

- (3) In deciding whether there are reasonable grounds for believing that property is subject to the effective control of the defendant, the court may take into account the matters in Section 32(2).
- (4) The order may be subject to any conditions that the court thinks fit and, without limiting this subsection, may provide for meeting, out of the property or a specified part of it, all or any of the following:
- (a) the person's reasonable living expenses, including the reasonable living expenses of the person's dependants, if any, and reasonable business expenses;
 - (b) the person's reasonable expenses in defending a criminal charge and any proceedings under this Act; or
 - (c) another specified debt incurred by the person in good faith.
- (5) The order shall not make such provision unless the court is satisfied that the person cannot meet the expenses or debt out of property that is not subject to a restraining order.
- (6) Where the court gives the Administrator a direction under subsection (2)(b) for property, the Administrator may do anything that is reasonably necessary to preserve the property and, for that purpose:
- (a) may do anything for the property that its owner could do; and
 - (b) may do so to the exclusion of the owner.
- (6A) An application under Section 48 shall be served on all persons interested in the application or such of them as the Supreme Court thinks expedient and all such persons shall have the right to appear at the hearing and be heard.

- (7) In proceedings for a restraining order, the court may order that a witness need not:
- (a) answer a specified question; or
 - (b) produce a specified document,

- (8) When the application is made under Section 48 on the basis that a person is about to be charged, any order made by the court shall lapse if the person is not charged:
- (a) within 28 days, where the offence is an offence against any written law of the Republic; or
 - (b) within 6 months, where the offence is an offence against the law of a foreign State.

51 Republic not required to give undertaking

For the purposes of making an order under Section 50 or any other Part of this Act, the Republic shall not be required to give an undertaking as to damages or costs.

52 Service of restraining order

- (1) A copy of a restraining order shall be served on a person affected by it in the way the court directs.
- (2) Where the court is satisfied that it is in the public interest to do so, it may order that service under subsection (1) be delayed for a specified period.

53 Ancillary orders and further orders

- (1) Where the court makes a restraining order, any of the following may apply to the court for an ancillary order:
 - (a) the Secretary for Justice;
 - (b) a person whose property is the subject of the restraining order (the “owner”);
 - (c) if the restraining order directs the Administrator to take custody and control of the property, the Administrator; or
 - (d) with the leave of the court, any other person.
- (2) An ancillary order may do any of the following:
 - (a) vary the property to which a restraining order relates;
 - (b) vary any condition to which a restraining order is subject;
 - (c) order a person to be examined on oath before the court about the affairs of the owner or of the defendant;
 - (d) provide for carrying out any undertaking about the payment of damages or costs given by the Republic in connection with the making of the restraining order;
 - (e) direct the owner or the defendant to give a specified person a statement on oath setting out the particulars of the property, or dealings with the property, that the court directs;
 - (f) if the restraining order directs the Administrator to take custody and control of property, do any of the following:

- (i) regulate the performance or exercise of the Administrator's functions, duties or powers under the restraining order;
 - (ii) decide a question about the property;
 - (iii) order a person to do anything to enable the Administrator to take custody and control of the property;
 - (iv) if the restraining order provides that a person's reasonable expenses in defending a criminal charge be met out of the property, order that those expenses be taxed as provided in the ancillary order before being met; or
 - (v) provide for the payment to the Administrator out of the property of the costs, charges and expenses incurred in connection with the performance or exercise by the Administrator of functions, duties or powers under the restraining order; or
 - (g) anything else that the court considers necessary in the circumstances.
- (3) Where a person who has an interest in property against which a restraining order is made applies to the court for a variation of the order to exclude the person's interest from the order, the court shall grant the application if the court is satisfied that:
- (a) the interest is not tainted property and that it cannot be required to satisfy a pecuniary penalty order;
 - (b) the applicant was not in any way involved in the commission of the offence for which the restraining order was made and, if the applicant acquired the interest at the time of or after the commission, or alleged commission, of the offence, the applicant acquired the interest:
 - (i) for sufficient consideration; and
 - (ii) without knowing, and in circumstances so as not to arouse a reasonable suspicion, that the property was tainted property; or
 - (c) it is in the public interest to do so having regard to all the circumstances, including any financial hardship or other consequence of the interest remaining subject to the order.
- (4) The court shall not hear an application made under subsection (1), unless the applicant has given reasonable written notice of the application to each person who is entitled to make an application under that subsection for the restraining order.
- (5) The court may require notice of the application to be given to, and may hear, any person who, in the opinion of the court, appears to have an interest in the property.
- (6) Where a person is required, in accordance with an order made under subsection (2)(c) or (e), to make a statement on oath:
- (a) the person is not excused from making the statement on the ground that the statement, or part of it, might tend to incriminate the person or make the person liable to forfeiture or to a penalty; and
 - (b) the statement, and any information, document or thing obtained as a direct or indirect consequence of it, is not admissible against the person in any criminal proceedings except a proceeding for perjury in making the statement.

54 Administrator may satisfy pecuniary penalty order

- (1) This Section applies if:

- (a) a pecuniary penalty order is made against a defendant in reliance on the defendant's conviction of a serious offence; and
- (b) a restraining order is made in reliance on the defendant's conviction, or alleged commission, of the offence, against property of:
 - (i) the defendant; or
 - (ii) another person for whom an order made under Section 32(4) is in force.
- (2) The court may direct the Administrator to satisfy the pecuniary penalty order by a payment to the Republic out of the property:
 - (a) on the making of the later of the orders; or
 - (b) on application by the Secretary for Justice, at any time while the restraining order remains in force.
- (3) To enable the Administrator to comply with a direction under subsection (2), the court may:
 - (a) direct the Administrator to sell or otherwise dispose of a part of the property that the court specifies; and
 - (b) order that the Administrator may execute, and do anything necessary to give validity and effect to, any deed or instrument in the name of a person who owns or has an interest in the property.
- (4) Where the court makes an order of the kind mentioned in subsection (3)(b), the execution of a deed or instrument by the Administrator in accordance with the order has the same force and validity as if the deed or instrument had been executed by the person in whose name the Administrator executed it.
- (5) The Administrator shall not take action to sell property under a direction made under subsection (2) until:
 - (a) the periods for the lodging of an appeal against the relevant conviction, and the making of the relevant pecuniary penalty order and restraining order, have expired without any appeal having been lodged; or
 - (b) if an appeal is lodged against a relevant conviction, or the making of the relevant pecuniary penalty order or restraining order, the appeal lapses in accordance with the rules of court or is finally determined.

55 Registration of restraining order

- (1) An authority that administers a law of the Republic that provides for the registration of title to, or charges over, property of a particular kind may, on application by the Secretary for Justice, record on a register kept under that written law the particulars of a restraining order that applies to property of that kind.
- (2) For the purposes of Section 56, if those particulars are so recorded, a person who subsequently deals with the property is taken to have notice of the restraining order at the time of the dealing.

56 Contravention of restraining order

- (1) A person who knowingly contravenes a restraining order by disposing of, or otherwise dealing with, property that is subject to the restraining order, commits an offence punishable by:
 - (a) for a natural person, a fine up to \$30,000 or a term of imprisonment up to 5 years or both; or

- (b) for a body corporate, a fine of up to \$150,000.
- (2) Where a restraining order is made against property and the property is disposed of, or otherwise dealt with, in contravention of the restraining order, the Secretary for Justice may apply to the court for an order setting aside the disposition or dealing.
- (3) Where the court is satisfied that the disposition or dealing was either not sufficient for consideration, or not in favour of a person who acted in good faith, the court may:
 - (a) set aside the disposition or dealing with effect from the day on which it took place; or
 - (b) set aside the disposition or dealing with effect from the day of the court's order, and declare the right of any person who acquired an interest in the property on or after the day on which the disposition or dealing took place and before the day of the order.

57 Variation, Discharge or dissolution of restraining order on provision of security or undertakings

- (1) Where the court has made a restraining order against a person's property, the court may, on application by the person, revoke the order:
 - (a) if the applicant is a defendant, the applicant gives security satisfactory to the court for the satisfaction of any pecuniary penalty order that may be made against the person under this Act; or
 - (b) the applicant gives undertakings satisfactory to the court about the property.
- (2) An applicant under subsection (1), shall give reasonable written notice of the application to the Secretary for Justice and, if the restraining order directed the Administrator to take control of property, the Administrator.
- (3) A person who has an interest in property in respect of which a restraining order was made may at any time apply to the Supreme Court for an order.

58 When restraining order ceases to be in force

- (1) A restraining order ceases to be in force at the end of 6 months after the day when it was made, unless it ceases sooner under subsection (5).
- (2) Within that period, on application by the Secretary for Justice, the court may order that the order continues in force until a specified time or event if the court is satisfied that:
 - (a) a forfeiture order may still be made against the property; or
 - (b) the property may be required to satisfy a pecuniary penalty order that has not yet been made.
- (3) An order made under subsection (2) does not have the effect of continuing a restraining order in force after the time when it would cease to be in force under subsection (5).
- (4) The Secretary for Justice shall give a person reasonable written notice of an application under subsection (2) about a restraining order against the person's property.
- (5) A restraining order made in reliance on a person's conviction, or of a serious offence ceases to be in force, in whole or in part:

- (a) if the order is made in reliance on the proposed charging of the person with the offence and the person is not so charged within the period of 48 hours after the making of the order, at the end of that period;
- (b) when the charge against the person is withdrawn or the person is acquitted of the charge;
- (c) when property subject to the order is used to satisfy a pecuniary penalty order that was made in reliance on the person's conviction of the offence;
- (d) when the court refuses an application for a pecuniary penalty order in reliance on the person's conviction of the offence; or
- (e) when property subject to the order is forfeited under Part 2.

DIVISION 4 — INTERIM RESTRAINING ORDERS FOR FOREIGN SERIOUS OFFENCES

59 Application of Sections 60, 61, 62, 63, 64, 65, 66, 67, 68 and 69

Sections 60, 61, 62, 63, 64, 65, 66, 67, 68 and 69 apply to an application by the Secretary for Justice for a restraining order under this Act against any property of a person in relation to a foreign serious offence, and to any restraining order made as a result of the application.

60 Definition of “defendant”

A person is a “*defendant*” for the purposes of Sections 61, 62, 63, 64, 65, 66, 67, 68 and 69 if:

- (a) he or she has been convicted of a foreign serious offence; or
- (b) there are reasonable grounds for believing that a criminal proceeding has commenced, or is about to be commenced, against him or her in a foreign country.

61 Application for interim restraining order

- (1) Where the Minister authorises the Secretary for Justice, under the *Mutual Assistance in Criminal Matters Act*, to apply for a restraining order under this Act against any property of a defendant, the Secretary for Justice may apply to the court for an interim restraining order against:
 - (a) any realisable property held by the defendant; or
 - (b) realised property, specified in the application, that is held by a person other than the defendant.
- (2) The application may be made *ex parte*.
- (3) The application shall be in writing, and shall be accompanied by an affidavit stating:
 - (a) if the defendant has been convicted of a foreign serious offence, the offence of which the defendant was convicted, the date of the conviction, the court before which the conviction was obtained and whether an appeal has been lodged against the conviction;
 - (b) if the defendant has not been convicted of a foreign serious offence, the offence for which criminal proceedings are believed to have been commenced, and the grounds for believing that the defendant committed the foreign serious offence;
 - (c) if it is believed that criminal proceedings are about to be commenced against the defendant, the grounds for believing that the proceedings will be commenced within 48 hours;
 - (d) a description of the property against which the restraining order is sought;
 - (e) the name and address of the person who is believed to be in possession of the property;
 - (f) if the application seeks a restraining order against property of a defendant, the grounds for believing that the property is tainted property in relation to a foreign serious offence, or that the defendant derived a benefit directly or indirectly from committing that offence; and
 - (g) if the application seeks a restraining order against property of a person other than a defendant, the grounds for believing that the property is

tainted property in relation to a foreign serious offence, or is subject to the effective control of the defendant.

62 Notice of application for interim restraining order

- (1) Before making an interim restraining order, the court shall require the Secretary for Justice to give reasonable written notice to any person who may have an interest in the property and may hear any person to whom notice is given.
- (2) Where the Secretary for Justice requests:
 - (a) the court shall consider the application without requiring notice to be given in accordance with subsection (1); but
 - (b) an interim restraining order made in reliance on this subsection ceases to have effect after 14 days or any lesser period that the court specifies in the order.
- (3) The court may, on application by the Secretary for Justice:
 - (a) extend the period of operation of an interim restraining order made in reliance on subsection (2); but
 - (b) shall not consider the application without requiring reasonable written notice to be given to any person who may have an interest in the property.

63 Interim restraining order

- (1) Subsection (2) applies if the Secretary for Justice applies to the court for an interim restraining order against property of a defendant and the court is satisfied that:
 - (a) the defendant has been convicted of a foreign serious offence, or a criminal proceeding for a foreign serious offence has commenced, or is reasonably believed to be about to commence, against the defendant in a foreign country;
 - (b) if the defendant has not been convicted of a foreign serious offence, the offence that the defendant is believed to have committed and the grounds for that belief; and
 - (c) if the application seeks a restraining order against property of a person other than a defendant, there are reasonable grounds for believing that the property is tainted property in relation to a foreign serious offence, or that the property is subject to the effective control of the defendant.
- (2) The court may make an order prohibiting the defendant or any other person from disposing of, or otherwise dealing with, the property, or any part of it or interest in it specified in the order, either absolutely or except in a way specified in the order.
- (3) An order made under subsection (2), may be subject to any conditions that the court thinks fit and, without limiting this subsection, may provide for meeting, out of the property or a specified part of it, all or any of the following:
 - (a) the person's reasonable living expenses, including the reasonable living expenses of the person's dependants, if any, and reasonable business expenses;

- (b) the person's reasonable expenses in defending a criminal charge and any proceedings under this Act or in being represented in a criminal proceeding in a foreign country; and
 - (c) another specified debt incurred by the person in good faith.
- (4) An order made under this Section shall not make provision under subsection (3), unless the court is satisfied that the person cannot meet the expenses or debt out of property that is not subject to a restraining order.
- (5) In deciding whether there are reasonable grounds for believing that property is subject to the effective control of the defendant, the court may take into account the matters in Section 32(2).
- (6) In proceedings for an order made under subsection (2), the court may order that a witness need not:
- (a) answer a specified question; or
 - (b) produce a specified document,
- if the court is satisfied that answering the question or producing the document may prejudice the investigation of, or prosecution of a person for, an offence.

64 Undertakings by the Republic

Before making an interim restraining order, the court may require the Republic to give an undertaking about the payment of damages or costs, or both, for the making and execution of the order.

65 Service of interim restraining order

- (1) A copy of an interim restraining order shall be served on a person affected by it in the way the court directs or as required by rules of court.
- (2) Where the court is satisfied that it is in the public interest to do so, it may order that service under subsection (1), be delayed for a specified period.

66 Ancillary orders and further orders

- (1) Where the court makes an interim restraining order, any of the following may apply to the court for an ancillary order:
 - (a) the Secretary for Justice;
 - (b) a person whose property is the subject of the interim restraining order (the "owner"); or
 - (c) with the leave of the court, any other person.
- (2) An ancillary order may do any of the following:
 - (a) vary the property to which an interim restraining order relates;
 - (b) vary any condition to which an interim restraining order is subject;
 - (c) order a person to be examined on oath before the court about the affairs of the owner or of the defendant;
 - (d) provide for carrying out any undertaking about the payment of damages or costs given by the Republic in connection with the making of the interim restraining order;
 - (e) order the owner or the defendant to give a specified person a statement on oath setting out the particulars of the property, or dealings with the property, that the court directs; or
 - (f) anything else that the court considers necessary in the circumstances.
- (3) Where a person who has an interest in property against which an interim

restraining order is made applies to the court for a variation of the order to exclude the person's interest from the order, the court shall grant the application if the court is satisfied that:

- (a) the applicant was not in any way involved in the commission of the offence for which the order was made, and, if the applicant acquired the interest at the time of or after the commission, or alleged commission, of the offence, that the applicant acquired the interest:
 - (i) for sufficient consideration; and
 - (ii) without knowing, and in circumstances so as not to arouse a reasonable suspicion, that the property was tainted property in relation to a foreign serious offence; or
 - (b) it is in the public interest to do so having regard to all the circumstances, including any financial hardship or other consequence of the interest remaining subject to the order.
- (4) The court shall not hear an application made under subsection (1), unless the applicant has given reasonable written notice of the application to each person who is entitled to make an application under that subsection for the interim restraining order.
- (5) The court may require notice of the application to be given to, and may hear, any person who, in the opinion of the court, appears to have an interest in the property.
- (6) Where a person is required, in accordance with an order made under subsection (2)(c) or (e), to make a statement on oath:
- (a) the person is not excused from making the statement on the ground that the statement, or part of it, might tend to incriminate the person or make the person liable to forfeiture or to a penalty; and
 - (b) the statement, and any information, document or thing obtained as a direct or indirect consequence of it, is not admissible against the person in any criminal proceedings except a proceeding for perjury in making the statement.

67 Registration of interim restraining order

- (1) An authority that administers a written law of the Republic that provides for the registration of title to, or charges over, property of a particular kind may, on application by the Secretary for Justice, record on a register kept under that law the particulars of an interim restraining order that applies to property of that kind.
- (2) For the purposes of Section 68, if those particulars are so recorded, a person who subsequently deals with the property is taken to have notice of the interim restraining order at the time of the dealing.

68 Contravention of interim restraining order

- (1) A person who knowingly contravenes an interim restraining order by disposing of, or otherwise dealing with, property that is subject to the interim restraining order, commits an offence punishable by:
 - (a) for a natural person, a fine of up to \$30,000 or a term of imprisonment of up to 5 years or both; or
 - (b) for a body corporate, a fine of up to \$150,000.
- (2) Where an interim restraining order is made against property and the

property is disposed of, or otherwise dealt with, in contravention of that order, the Secretary for Justice may apply to the court for an order setting aside the disposition or dealing.

- (3) Where the court is satisfied that the disposition or dealing was either not for sufficient consideration or not in favour of a person who acted in good faith, the court may:
 - (a) set aside the relevant disposition or dealing with effect from the day on which it took place; or
 - (b) set aside the disposition or dealing with effect from the day of the court's order, and declare the right of any person who acquired an interest in the property on or after the day on which the disposition or dealing took place and before the day of the order.

69 When interim restraining order ceases to be in force

- (1) An interim restraining order ceases to be in force at the end of 30 days starting on the day on which the order is made.
- (2) Where:
 - (a) the court makes an interim restraining order, it may, on application by the Solicitor-General made before the end of the period mentioned in subsection (1), extend the period of operation of the order; and
 - (b) an interim restraining order is made against property and before the end of the period referred to in subsection (1), including any extension of that period under paragraph (a), a foreign restraining order against the property is registered in the court under the *Mutual Assistance in Criminal Matters Act*,

the interim restraining order ceases to have effect when the foreign restraining order is registered.

DIVISION 5 — FOREIGN RESTRAINING ORDERS

70 Application of Sections 72, 73, 74, 75, 76 and 77

Sections 72, 73, 74, 75, 76 and 77 apply to:

- (a) a foreign restraining order registered in the court under the *Mutual Assistance in Criminal Matters Act*; and
- (b) an order for custody and control made under Section 71.

71 Foreign restraining orders - court may direct Administrator to take custody and control of property

- (1) On application by the Secretary for Justice, the court may, if satisfied that the circumstances so require, order the Administrator:
 - (a) to take custody and control of the property subject to the order or of any part of it specified in the order; and
 - (b) to manage or otherwise deal with the property or part in accordance with the directions of the court.
- (2) Before making an order under subsection (1), the court shall require reasonable notice to be given to, and may hear, any person who, in the opinion of the court, may have an interest in the property.
- (3) Where the court makes an order under subsection (1) for property, the Administrator:

- (a) may do anything that is reasonably necessary for preserving the property;
 - (b) for that purpose may exercise any power that the owner of the property could exercise; and
 - (c) may do so to the exclusion of the owner.
- (4) Where the court makes an order under subsection (1) against property of a person (the “respondent”), the court may, when it makes the order or afterwards, make any of the following orders:
- (a) an order directing the respondent to give the Administrator a statement on oath setting out the particulars of the property, or dealings with the property, as the court directs;
 - (b) an order regulating the performance or exercise of the Administrator’s functions, duties or powers under the foreign restraining order;
 - (c) an order deciding any question about the property;
 - (d) if the relevant registered foreign restraining order provides that a person’s reasonable expenses in defending a criminal charge shall be met out of the property, an order directing that those expenses be taxed, as provided in the order, before being met; or
 - (e) an order providing for the payment to the Administrator out of the property of the costs, charges and expenses incurred in connection with the performance or exercise by the Administrator of functions, duties or powers under the foreign restraining order.

72 Foreign restraining orders - undertakings

On application by a person claiming an interest in the property, the court may make an order about giving, or carrying out, an undertaking by the Secretary for Justice, for the Republic, about the payment of damages or costs for the registration, making or operation of:

- (a) a foreign restraining order against property that is registered in the court under the *Mutual Assistance in Criminal Matters Act*; or
- (b) an order made by the court under Section 71.

73 Service of restraining order

- (1) A copy of a foreign restraining order or an order made under Section 71 shall be served on a person affected by it in any way the court directs or as required by rules of court.
- (2) Where the court is satisfied that it is in the public interest to do so, it may order that service under subsection (1) be delayed for a specified period.

74 Administrator to satisfy pecuniary penalty order

- (1) In this Section, a reference to a foreign restraining order includes an order under Section 71.
- (2) This Section applies if:
 - (a) a foreign pecuniary penalty order is registered in the court against a defendant; and
 - (b) a foreign restraining order is registered against property of:
 - (i) the defendant; or
 - (ii) another person for whom an order made under Section 32(4) is in force.

- (3) The court may direct the Administrator to satisfy the pecuniary penalty order by a payment to the Republic out of the property:
 - (a) on the registration of the later of the orders; or
 - (b) on application by the Secretary for Justice, at any time while the restraining order remains in force.
- (4) To enable the Administrator to comply with a direction under subsection (3), the court may:
 - (a) direct the Administrator to sell or otherwise dispose of a specified part of the property; and
 - (b) order that the Administrator may execute, and do anything necessary to give validity and effect to, any deed or instrument in the name of a person who owns, or has an interest in, the property.
- (5) Where the court makes an order of the kind mentioned in subsection (4)(b), the execution of a deed or instrument by the Administrator in accordance with the order has the same force and validity as if the deed or instrument had been executed by the person in whose name the Administrator executed it.

75 Registration of foreign restraining order

- (1) In this Section, a reference to a foreign restraining order includes an order under Section 71.
- (2) An authority that administers a written law of the Republic that provides for the registration of title to, or charges over, property of a particular kind may, on application by the Secretary for Justice, record on a register kept under that law the particulars of a foreign restraining order that applies to property of that kind.
- (3) For the purposes of Section 76, if those particulars are so recorded, a person who subsequently deals with the property is taken to have notice of the restraining order at the time of the dealing.

76 Contravention of foreign restraining orders registered under Section 75

- (1) In this Section, a reference to a foreign restraining order includes an order under Section 71.
- (2) A person who knowingly contravenes a foreign restraining order registered under Section 75 by disposing of, or otherwise dealing with, property that is subject to the restraining order, commits an offence punishable by:
 - (a) for a natural person, a fine up to \$30,000 or a term of imprisonment up to 5 years or both; or
 - (b) for a body corporate, a fine up to \$150,000.
- (3) Where a foreign restraining order is registered under Section 75 against property and the property is disposed of, or otherwise dealt with, in contravention of the restraining order, the Secretary for Justice may apply to the court for an order setting aside the disposition or dealing.
- (4) Where the court is satisfied that the disposition or dealing was either not for sufficient consideration or not in favour of a person who acted in good faith, the court may:
 - (a) set aside the relevant disposition or dealing with effect from the day on which it took place; or

- (b) set aside the disposition or dealing with effect from the day of the court's order, and declare the right of any person who acquired an interest in the property on or after the day on which the disposition or dealing took place and before the day of the order.

77 Foreign restraining order registered under Mutual Assistance in Criminal Matters Act - when order ceases to be in force

A foreign restraining order registered in the court under the *Mutual Assistance in Criminal Matters Act* ceases to be in force when the registration is cancelled in accordance with that Act.

DIVISION 6 — PRODUCTION ORDERS AND OTHER INFORMATION GATHERING POWERS

78 Definition of “production order”

In Sections 79, 80, 81, 82, 83, 84, 85 and 86, “*production order*” includes an order that requires a person to make a document available for inspection.

79 Application for production orders

- (1) Subsection (2) applies if:
- (a) a person has been convicted of a serious offence and there are reasonable grounds for suspecting that a person has possession or control of a property-tracking document or property-tracking documents for the offence; or
 - (b) there are reasonable grounds for suspecting that a person has committed a serious offence and that a person has possession or control of a property-tracking document or property-tracking documents for the offence.
- (2) A police officer may apply to a Resident Magistrate for a production order against the person.
- (3) The application:
- (a) may be made *ex parte*; and
 - (b) shall be in writing and shall be accompanied by an affidavit.
- (4) Subsection (5) applies if a police officer applies for a production order for a serious offence, and includes in the affidavit a statement to the effect that there are reasonable grounds for believing that:
- (a) the person who was convicted of the offence, or who is believed to have committed the offence, derived a benefit, directly or indirectly, from the commission of the offence; and
 - (b) the property specified in the affidavit is under the effective control of the person mentioned in paragraph (a).
- (5) For the purposes of this Section, the Resident Magistrate hearing the application may treat any document relevant to identifying, locating or quantifying that property as a property tracking document for the offence.
- (6) In deciding whether to treat a document as a property-tracking document for an offence, the Resident Magistrate may take into account the matters mentioned in Section 32(2).

80 Production orders

- (1) The Resident Magistrate may, if satisfied that there are reasonable grounds for doing so, make a production order requiring a person:

- (a) to produce to a police officer, at a specified time and place, any documents of the kind mentioned in Section 79(1) that are in the person's possession or control; or
 - (b) to make available to a police officer for inspection, at a specified time or times and place or places, any documents of that kind that are in the person's possession or control.
- (2) The order has effect despite any written law that prohibits disclosure of information.
- (3) Where a production order requires a person to produce or make available a document that is a computer file, the order is taken to require the person:
- (a) to allow the police officer named in the order, or a person acting under the direction of that officer, to use a computer on which the document is held;
 - (b) to give the officer any password necessary to provide the officer with access to the document; and
 - (c) to enable the officer to use any computer software necessary to provide the officer with access to the document.

81 Scope of police powers under production order

- (1) Where a document is produced to a police officer, or made available to a police officer for inspection, under a production order, the police officer may do any of the following:
- (a) inspect the document;
 - (b) take extracts from it;
 - (c) print it;
 - (d) make copies of it; or
 - (e) for an order made under Section 80(1)(a), keep the document if, and for as long as, reasonably necessary for the purposes of this Act.
- (2) Where a police officer keeps a document, the police officer shall:
- (a) make a copy of the document, certify the copy in writing to be a true copy, and give the copy to the person to whom the order was addressed; or
 - (b) allow the person:
 - (i) to inspect the document;
 - (ii) to take extracts from it; or
 - (iii) to make copies of it.

82 What use can be made of information

- (1) Where a person produces or makes available, a document under a production order:
- (a) the production or making available of the document; or
 - (b) any information, document or thing obtained as a direct or indirect consequence of the production or making available of the document, is not admissible against the person in any criminal proceedings except a proceeding for an offence under Section 84.
- (2) A person required by a production order to produce or make available a document is not excused from doing so on the ground that producing the document or making it available:

- (a) might tend to incriminate the person or make the person liable to a penalty; or
- (b) would be in breach of an obligation, whether imposed by a written law or otherwise, not to disclose the existence or contents of the document.

83 Variation of production order

- (1) Where a production order requires a person to produce a document to a police officer, the person may apply to a Resident Magistrate to vary the order.
- (2) Where the Resident Magistrate is satisfied that the document is essential to the person's business activities, the Resident Magistrate may vary the production order so that it requires the person to make the document available to a police officer for inspection.

84 Failure to comply with production order

- (1) Where a production order requires a person to produce a document to a police officer, or make a document available to a police officer for inspection, the person commits an offence if the person:
 - (a) contravenes the order without reasonable excuse; or
 - (b) in purported compliance with the order, produces or makes available a document that the person knows to be false or misleading in a material particular without:
 - (i) telling the police officer that the document is false or misleading, and the way in which it is false or misleading; and
 - (ii) giving correct information to the police officer if the person has, or can reasonably obtain, the correct information.
- (2) An offence against subsection (1), is punishable by:
 - (a) if the offender is a natural person, a fine up to \$30,000 or a term of imprisonment up to 5 years or both; or
 - (b) if the offender is a body corporate, a fine up to \$150,000.

84A Powers to search for and seize documents relevant to locating property

- (1) Subject to subsection (2), a police officer may:
 - (a) enter upon land or upon or into premises; and
 - (b) search the land or premises for any property-tracking document;
 - (c) seize any document found in the course of that search that the police officer believes on reasonable grounds to be a relevant document in relation to tainted property; and
 - (d) any other document storage device including storage in electronic and digital database device.
- (2) The entry, search and seizure shall be made:
 - (a) with the consent of the occupier of the land or the premises; or
 - (b) under a warrant issued under Section 85.

85 Application for search warrant

- (1) Where a police officer has reasonable grounds to believe that a person:

- (a) has been or will be involved in the commission of serious offence; or
 - (b) has or will have possession of control of any property-tracking document,
the police officer may file an application supported by information on oath to the court for a search warrant in respect of land or any building on such land.
- (2) Where an application is made for a warrant to search land or building, the court may, subject to subsection (3), issue a warrant authorising a police officer with such assistance and by such force as is reasonable to:
- (a) enter upon the land or any building on such land to search for any property-tracking document; and
 - (b) seize any property-tracking document found in the course of the search that the police officer believes on reasonable grounds to be such documents.
- (3) The Judge shall not issue a warrant unless he or she is satisfied that:
- (a) a production order has been given in respect of the document and has not been complied with;
 - (b) a production order in respect of the document is not likely to be effective;
 - (c) the investigation for the purposes of which the search warrant is being sought might be seriously prejudiced if the police officer does not gain immediate access to the document without any notice to any person; or
 - (d) the document involved cannot be identified or described with sufficient particularity to enable a production order to be obtained.
- (4) The warrant shall state:
- (a) the purpose for which it is issued, including a reference to the nature of the relevant offence, if any;
 - (b) a description of the kind of documents authorised to be seized;
 - (c) a time at which the warrant ceases to be in force; and
 - (d) whether entry is authorised to be made at any time of the day or night or during specified hours.
- (5) Where during the course of searching under the warrant, a police officer finds:
- (a) a property-tracking document that the police officer believes on reasonable grounds to relate to other serious offence or to terrorist property; or
 - (b) any thing that the police officer believes on reasonable grounds will afford evidence as to the commission of serious offence, the police officer may seize that property or thing and the warrant shall be deemed to authorise such seizure.

86 Foreign State requesting assistance

The provisions of this Division apply with appropriate modifications, where:

- (a) a foreign State requests assistance to locate or seize a property-tracking document; and

(b) the Minister has under a relevant written law authorised the giving of assistance to the foreign State.

PART 4 — MONITORING ORDERS

87 Monitoring orders

- (1) The Secretary for Justice may apply *ex parte*, supported by an affidavit to the court for a monitoring order directing a financial institution to give information to a police officer.
- (2) A monitoring order shall:
 - (a) direct a financial institution to disclose information obtained by the institution about transactions conducted through an account held by a particular person with the institution;
 - (b) not have retrospective effect; and
 - (c) apply for a period of a maximum of 3 months from the date the order is granted.
- (3) The Judge shall not issue a monitoring order unless he or she is satisfied that there are reasonable grounds for suspecting that:
 - (a) the person in respect of whose account the order is sought:
 - (i) has committed or was involved in the commission, or is about to commit or be involved in the commission of, a serious offence; or
 - (ii) has benefited directly or indirectly, or is about to benefit directly or indirectly from the commission of the serious offence; or
 - (b) the account is relevant to identifying, locating or quantifying terrorist property.

88 Contents of monitoring order

- (1) A monitoring order shall:
 - (a) specify the name or names in which the account is believed to be held;
 - (b) specify the kind of information that the financial institution is required to provide;
 - (c) specify the period during which the transaction shall have occurred;
 - (d) specify to which enforcement agency the information is to be provided;
 - (e) specify the form and manner in which the information is to be given; and
 - (f) set out the effect of failing to comply with a monitoring order.
- (2) The period in subsection (1)(c) shall:
 - (a) begin no earlier than the day on which notice of the monitoring order is given to the financial institution; and
 - (b) end no later than 6 months after the date of the order.

89 Protection from suits for those complying with monitoring order

- (1) No action, suit or proceedings lies against:
 - (a) a financial institution; or
 - (b) an officer, employee or agent of the financial institution acting in the course of that person's employment or agency, in relation to any action

taken by the financial institution or person in complying with a monitoring order or in the mistaken belief that action was required under the order.

- (2) A financial institution, or person who is an officer, employee or agent of a financial institution, who provides information under a monitoring order is taken, for purposes of offences relating to money laundering, not to have been in possession of that information at any time.

90 Making false statement in application

- (1) A person is guilty of an offence if:
 - (a) the person makes a statement, whether orally, in a document or any other way;
 - (b) the statement:
 - (i) is false or misleading; or
 - (ii) omits any matter or thing without which the statement is misleading; and
 - (c) the statement is made in, or in connection with, an application for a monitoring order.
- (2) An offence against subsection (1) is punishable by a fine up to \$20,000 or a term of imprisonment up to 2 years or both.

91 Disclosing existence or operation of monitoring order

- (1) A person is guilty of an offence if:
 - (a) the person discloses the existence or the operation of a monitoring order to another person;
 - (b) the disclosure is not to a person mentioned in subsection (5); and
 - (c) the disclosure is not for a purpose mentioned in subsection (5).
- (2) A person is guilty of an offence if:
 - (a) the person discloses information to another person;
 - (b) that other person could infer the existence or operation of a monitoring order from that information;
 - (c) the disclosure is not to a person mentioned in subsection (5); and
 - (d) the disclosure is not for a purpose mentioned in subsection (5).
- (3) A person is guilty of an offence if:
 - (a) the person receives information relating to a monitoring order in accordance with subsection (5);
 - (b) the person ceases to be a person to whom information could be disclosed in accordance with subsection (5); and
 - (c) the person makes a record of, or discloses, the existence or the operation of the order.
- (4) An offence against subsections (1), (2) and (3), is punishable by a fine up to \$20,000 or a term of imprisonment up to 2 years or both.
- (5) A person may disclose the existence or the operation of a monitoring order to the following persons for the following purposes:
 - (a) the Secretary for Justice, Director of Public Prosecutions or an authorised officer:
 - (i) for the purpose of performing that person's duties;
 - (ii) for the purpose of, or for purposes connected with, legal proceedings; or

- (iii) for the purposes arising in the course of proceedings before a court;
- (b) the Financial Intelligence Unit Supervisor, or a member of the staff of the Financial Intelligence Unit who is authorised by the Financial Intelligence Unit Supervisor as a person who may be advised of the existence of a monitoring order:
 - (i) for the purpose of performing that person's duties;
 - (ii) for the purpose of, or for purposes connected with, legal proceedings; or
 - (iii) for purposes arising in the course of proceedings before a court;
- (c) an officer or agent of the financial institution for the purpose of ensuring that the order is complied with; and
- (d) a legal practitioner for the purpose of obtaining legal advice or representation in relation to the order.

92 Failure to comply with monitoring order

A person who is given a monitoring order and fails to comply with the order is guilty of an offence punishable by a fine up to \$20,000 or a term of imprisonment up to 2 years or both.

**PART 5 — DISCLOSURE OF INFORMATION HELD BY GOVERNMENT
DEPARTMENTS**

93 Direction to disclose information

- (1) This Section applies to a document or information:
 - (a) that is in the possession or under the control of a person in charge of a Government department or a statutory body; or
 - (b) to which the person has access.
- (2) Notwithstanding any other written law, the Secretary for Justice may direct the person to give or disclose, to the Secretary for Justice or an authorised officer, the document or information if the Secretary for Justice is satisfied that the document or information is relevant to:
 - (a) establishing whether a serious offence has been, or is being, committed; or
 - (b) the making, or proposed or possible making, of an order under Part 2 or 3.

94 Further disclosure of information and documents

- (1) A person to whom a document or information has been disclosed under Section 93 shall not further disclose the document or information except for:
 - (a) the investigation of, or the prosecution, or proposed or possible prosecution of, a person for a serious offence; or
 - (b) an investigation relating to proceedings, or proposed or possible proceedings, for the making of an order under this Act or for an investigation relating to the making, or proposed or possible making, of an order.
- (2) A person to whom a document or information has been disclosed in accordance with this Part shall not disclose the document or information to another person except for a purpose mentioned in subsection (1)(a) or (b).
- (3) Where a document or information is disclosed to a person under Section 82 or subsection (1) or (2), the person:
 - (a) shall not voluntarily give the document or information in evidence in a proceeding before the court other than a proceeding of a kind mentioned in subsection (1)(a) or (b); and
 - (b) may not be required to give the document or information to the court.
- (4) A person who discloses a document or information in contravention of this Section is guilty of an offence punishable by a fine up to \$20,000 or a term of imprisonment up to 2 years or both.

95 Evidential value of copies

- (1) A document that is examined by or given to the Secretary for Justice or an authorised officer under a direction given under Section 93 may be copied by:
 - (a) the person who examines it or to whom it is given; or

-
- (b) an officer or person authorised for the purpose by the person in charge of the Government department or statutory body to which the direction was given.
 - (2) A copy purporting to be certified by the person in charge of the Government department or statutory body to be a copy made under subsection (1):
 - (a) is evidence of the nature and content of the original document; and
 - (b) has the same probative force as the original document would have had if it had been proved in the ordinary way.

**PART 6 — CURRENCY REPORTING AND SUSPICIOUS CURRENCY
MOVEMENTS**

96 Cross-border movement of currency and certain other items

- (1) This Section applies to any person who is about to leave or has arrived in the Republic with more than \$5,000 in:
 - (a) cash on his or her person or in his or her luggage;
 - (b) bearer negotiable instruments on his or her person or in his or her luggage; or
 - (c) precious metals or precious stones, gold, silver, diamonds or sapphire on his or her person or in his or her luggage.
- (2) The person shall make a declaration in the form prescribed by regulations to an authorised officer before leaving or on arrival in the Republic.
- (3) A person who fails to make a declaration or makes a declaration that the person knows is false or misleading in a material particular, commits a strict liability offence and shall be liable to a fine not exceeding \$20,000 or an imprisonment term not exceeding 2 years or to both.
- (4) An authorised officer may, with any assistance as is reasonable and necessary and with use of force as is necessary, take action under subsection (5) where a person:
 - (a) is about to leave the Republic or has arrived in the Republic; or
 - (b) is about to board or leave, or has boarded or left, any ship or aircraft in the Republic.
- (5) For the purpose of determining whether a person has with or on him or her any currency, bearer negotiable instruments or precious metals or precious stones of the kind referred to in subsection (1), the authorised officer may:
 - (a) examine any article which the person has with him or her or in his or her luggage; and
 - (b) where the officer has reasonable grounds to suspect that an offence under subsection (3) may have been or is being committed, search the person.
- (6) An authorised officer and any person assisting that officer, may stop, board and search any ship, aircraft or conveyance for the purposes of exercising the powers conferred by subsection (5).
- (7) The Cabinet may make regulations to prescribe requirements and procedures for ensuring compliance with this Section.

96A Cross-border movement of currency and certain other items-individuals-cargo and mail

- (1) This Section applies to the physical transportation in and out of the Republic of:
 - (a) cash with a value of more than \$5,000;
 - (b) bearer negotiable instruments with a value of more than \$5,000; or
 - (c) precious metals or precious stones including gold, silver, diamonds or sapphire with a value of more than \$5,000.
- (2) The person transporting the cash, bearer negotiable instruments, precious

metals or precious stones shall make a declaration in the form as may be prescribed before the cash, bearer negotiable instruments, precious metals or precious stones leaves the Republic or on arrival in the Republic.

- (3) A person who fails to make a declaration or makes a declaration that the person knows is false or misleading in a material particular commits a strict liability offence and shall be liable:
- (a) in the case of an individual, to a fine not exceeding \$20,000 or an imprisonment term not exceeding 2 years or to both; or
 - (b) in the case of a body corporate, to a fine not exceeding \$50,000; and
 - (c) to the forfeiture of any cash, bearer negotiable instruments or precious metals, stones including gold, silver, diamonds or sapphire intended to be transported in and out of the Republic.
- (4) Where an authorised officer has reasonable grounds to suspect that subsection (3) has been contravened, the officer may search the mail or cargo for the purpose of determining whether it contains any currency, bearer negotiable instruments or precious metals or precious stones of the kind referred to in subsection (1):
- (a) engage such assistance as is reasonable and necessary; and
 - (b) use such force as is necessary.
- (5) An authorised officer, and any person assisting that officer, may stop, board and search any ship, aircraft or conveyance for the purposes of exercising the powers conferred by subsection (4).

96B Reporting of declaration etc to the Financial Intelligence Unit

Without limiting Section 96A(4), where an authorised officer suspects on reasonable grounds that:

- (a) a declaration has not been made as required under Section 96 or 96A; or
- (b) a false or misleading declaration was made,

the authorised officer shall report the matter to the Financial Intelligence Unit after receiving the declaration or forming the suspicion.

97 Seizure of currency, bearer negotiable instruments or precious metals or stones

An authorised officer or a customs officer may seize and detain any currency, bearer negotiable instrument, or precious metals or stones including gold, silver, diamonds or sapphire that are being imported into or exported from the Republic, whether or not they are found in a search under Section 96 or 96A, where there are reasonable grounds for believing that:

- (a) they are derived from tainted property;
- (b) they are intended by any person for use in the commission of a serious offence;
- (c) there has been a failure to make a declaration under Section 96 or 96A; or
- (d) a false or misleading declaration has been made under Section 96 or 96A.

98 Detention of seized currency or bearer negotiable instrument

(1) Currency or any bearer negotiable instrument detained under Section 97, may not be detained for more than 28 days after it is seized.

(2) The court may order its continued detention for a period not exceeding 3 months from the day it is seized on being satisfied that:

(a) there are reasonable grounds for the suspicion in Section 97; and

(b) its continued detention is justified while:

(i) its origin or derivation is further investigated; or

(ii) consideration is given to the institution, in the Republic or elsewhere, of criminal proceedings against a person for an offence with which the currency or negotiable bearer instrument is connected.

(3) The court may subsequently order the continued detention of the currency or bearer negotiable instrument if satisfied of the matters mentioned in subsections (2)(a) and (b) but the total period of detention may not exceed 2 years from the date of the first order made under subsection (2).

99 Release of detained currency or bearer negotiable instrument

(1) Currency or any bearer negotiable instrument detained under Section 98 may be released in whole or in part to the person on whose behalf it was imported or exported, if:

(a) on application by or for that person and after considering any views of the Secretary for Justice to the contrary, the court orders that its continued detention is no longer justified; or

(b) an authorised officer is satisfied that its continued detention is no longer justified.

(2) Any currency or a bearer negotiable instrument detained under Section 98 shall not be released if:

(a) an application is made for:

(i) a pecuniary penalty order or an order made under Section 23, against the whole or any part of the currency or bearer negotiable instrument;

(ii) a restraining order against it pending determination of its liability to confiscation; or

(iii) the registration of a foreign pecuniary penalty order or foreign restraining order against it; or

(b) proceedings are under way in the Republic or elsewhere against a person for the offence with which the currency is connected,

until the proceedings relating to the relevant application, or the proceedings for the offence, have been concluded.

PART 7 — MISCELLANEOUS

100 Confiscated Assets Fund

- (1) There is established a fund known as the Confiscated Assets Fund (“the Fund”).
- (2) The Fund shall be administered by the Secretary for Finance.
- (3) Without further appropriation than this Section, the following shall be paid into the Fund:
 - (a) money paid to the Republic instead of a forfeiture order under Section 23;
 - (b) money paid to the Republic under a pecuniary penalty order under Section 26; and
 - (c) money paid to the Republic by a foreign jurisdiction in respect of confiscated assets, whether under a treaty or arrangement providing for mutual assistance in criminal matters or otherwise.
- (4) The Secretary for Finance, with the approval of the Minister for Finance, may authorise payments to be made out of the Fund:
 - (a) for purposes related to law enforcement, including in particular the investigation of suspected cases of money laundering;
 - (b) to satisfy an obligation of the Republic to a foreign jurisdiction in respect of confiscated assets, whether under a treaty or arrangement providing for mutual assistance in criminal matters or otherwise;
 - (c) to meet the remuneration and expenses of the Administrator;
 - (e) to pay compensation or costs awarded under this Act; and
 - (f) to cover costs associated with the administration of the Fund.

101 Conduct by directors, servants or agents

- (1) For the purposes of this Act, the state of mind of a person may be established in accordance with this Section.
- (2) For conduct engaged in, or taken under subsection (3) to have been engaged in, by a body corporate, it is sufficient to show that a director, servant or agent of the body corporate who engaged in the conduct within the scope of his or her actual or apparent authority had that state of mind.
- (3) For the purposes of this Act, conduct engaged in for a body corporate is taken to have been engaged in by the body corporate if it is engaged in:
 - (a) by a director, servant or agent of the body corporate within the scope of his or her actual or apparent authority; or
 - (b) both:
 - (i) by another person at the direction of, or with the consent or agreement, whether express or implied of, a director, servant or agent of the body corporate; and
 - (ii) if giving the direction, consent or agreement is within the scope of the actual or apparent authority of the director, servant or agent.
- (4) For conduct taken, under subsection (5), to have been engaged in by a person, other than a body corporate, it is sufficient to show that a servant or agent of the person who engaged in the conduct within the scope of his or her actual or apparent authority had that state of mind.

- (5) For the purposes of this Act, conduct engaged in for a person, other than a body corporate, is taken, for this Act, to have been engaged in by the person if it is engaged in by:
- (a) a servant or agent of the person within the scope of the servant or agent's actual or apparent authority; or
 - (b) by another person at the direction of, or with the consent or agreement (whether express or implied) of, a servant or agent of the first-mentioned person if the giving of the direction, consent or agreement is within the scope of the actual or apparent authority of the servant or agent.
- (6) In this Section, a reference to the state of mind of a person includes the person's knowledge, intention, opinion, belief or purpose, and the person's reasons for that intention, opinion, belief or purpose.

102 Appointment of Administrator

Under this Act, the Minister may, by instrument, appoint a person to administer property that is forfeited or subject to a restraining order.

103 Standard of proof

Except as otherwise provided in this Act, a question of fact to be decided by the court in proceedings under this Act shall be decided on the balance of probabilities.

104 Costs

- (1) The court may order the Republic to pay all costs reasonably incurred by a person in connection with proceedings, or a part of any proceedings, if:
- (a) the person brings, or appears at, the proceedings under this Act before a court:
 - (i) to prevent a forfeiture order, pecuniary penalty order, an order made under Section 23 or a restraining order, from being made against property of the person; or
 - (ii) to have property of the person excluded from a forfeiture order, pecuniary penalty order, an order made under Section 23 or a restraining order;
 - (b) the person is successful in those proceedings; and
 - (c) the court is satisfied that the person was not involved in any way in the commission of the offence for which the forfeiture order, pecuniary penalty order, order made under Section 23 or restraining order, was sought or made.
- (2) Any order issued under subsection (1), shall specify the costs to be paid to the Republic.

105 Non-liability of Administrator

The Administrator is not personally liable for any act done, or omitted to be done, by him or her in performing the Administrator's functions under this Act.

106 Operation of certain other laws not affected

Nothing in this Act prejudices, limits or restricts:

- (a) the operation of any other written law that provides for the forfeiture of property or the imposition of penalties or fines;
- (b) the remedies available to the Republic, apart from under this Act, for the enforcement of its rights and the protection of its interests; or
- (c) any power of search or any power to seize or detain property that is exercisable by a police officer apart from under this Act.

107 Appeal by the Republic

The Secretary for Justice may in accordance with the rules of the court appeal any order made under any Part of this Act or made under any provision of this Act.

108 Application of this Act to *Anti-Money Laundering and Targeted Financial Sanctions Act 2023* and *Counter Terrorism and Transnational Organised Crime Act 2004*

- (1) This Act applies to the process, procedure and enforcement of the confiscation, forfeiture, determination of competing interest of persons or disposal of criminal property or terrorist property under the *Anti-Money Laundering and Targeted Financial Sanctions Act 2023* and *Counter Terrorism and Transnational Organised Crime Act 2004*.
- (2) The references to the offences and description of property which is the subject of a proceeds of crime described under the *Anti-Money Laundering and Targeted Financial Sanctions Act 2023* and *Counter Terrorism and Transnational Organised Crime Act 2004* *mutatis mutandis* apply to the reference to any tainted property under this Act, for the purposes of this Act.

109 Regulations

- (1) The Cabinet may make regulations to prescribe matters that are required or permitted by this Act to be prescribed or are necessary or convenient to be prescribed for carrying out or giving effect to this Act and generally for achieving the purposes of this Act.
- (2) Without limiting the generality of subsection (1), regulations may be made for the following purposes of:
 - (a) determining whether or not the amount of currency exceeds any prescribed amount, the manner and method of determining whether any currency denominated in a foreign currency is taken to be the equivalent in the domestic currency;
 - (b) prescribing forms for this Act;
 - (c) the management and disposal of property that is subject to an order made under this Act; or
 - (d) prescribing matters necessary for the implementation of Sections 96 and 96A.

110 Transitional provision

1 Citation

These Regulations may be cited as the *Proceeds of Crime (Border Declaration Form) Regulations 2023*.

2 Commencement

These Regulations commence on the day they are notified in the Gazette.

3 Border Declaration Form

(1) A person transporting into or out of the Republic, in the value of more than \$5,000 of or its equivalence in any other currency:

- (a) cash;
 - (b) bearer negotiable instrument; or
 - (c) precious metals or precious stones,
- shall make a declaration in the Form in the Schedule.

(2) The Nauru Customs Service shall provide a copy each of the Border Declaration Form to the Financial Intelligence Unit.

4 Record keeping

(1) A declaration made in the Form in the Schedule, shall be kept and maintained for a period of 7 years by the:

- (a) Nauru Customs Service; and
- (b) Financial Intelligence Unit.

(2) An electronic declaration made for the purposes of this Regulation or any other written law, shall be kept and maintained in an electronic storage database or system.

5 Declaration of transportation of cash and other items by mail or cargo

(1) Where cash, bearer negotiable instruments, precious metals or stones including sapphire, gold and silver are transported from or into the Republic through mail or cargo, the manifest for such transportation shall be appropriately recorded the following in the Customs system:

- (a) amount in Australian dollars or its equivalent in foreign currency; and
- (b) value of any of the precious sapphire, gold and silver in Australian dollars or its equivalent in foreign currency.

(2) The Nauru Customs Service shall report the transportation of cash, bearer negotiable instruments, precious metals or stones including sapphire, gold and silver under subregulation (1) to the Financial Intelligence Unit.

- (3) The Financial Intelligence Unit shall ensure to keep and maintain all reports received under subregulation (2), on a monthly basis, for a period of 7 years.
 - (4) For the purpose of this Regulation '*Customs system*' has the meaning given to it under the *Customs Regulations 2023*.

The Cabinet makes the following Regulations under Section 107 of the *Proceeds of Crime Act 2004*:

1 Citation

These Regulations may be cited as the *Proceeds of Crime (Miscellaneous) Regulations 2023*.

2 Commencement

These Regulations commence on the day they are notified in the Gazette.

3 Ancillary orders and further orders

- (1) For the purpose of Section 53(2)(a), the court in varying the property to which an order relates, may order the restraining of a property of corresponding value, such value being equal to the value of the property which cannot be made subject to a restraining order.
- (2) For the purposes of subregulation (1), a property cannot be made subject to a restraining order where:
 - (a) it cannot with exercise of due diligence, be found;
 - (b) has been transferred to a third party in circumstances that do not give rise to a reasonable inference that the title or interest was transferred to avoid the forfeiture of the property;
 - (c) is located outside the Republic;
 - (d) has been mingled with other property that cannot be divided without difficulty; or
 - (e) has been substantially diminished in value or rendered worthless.

4 Physical transportation of cash

For the purpose of Sections 96 and 96A, the physical transportation of cash, bearer negotiable instrument, precious metals or precious stones including gold, silver, diamonds or sapphire includes the transportation of such:

- (a) on a person;
- (b) by mail;
- (c) in the person's cargo; or
- (d) in the person's luggage.

5 Duty of authorised officer to request and obtain information

For the purposes of Sections 96 and 96A, an authorised officer may stop and detain any person and ask the person questions to ascertain whether the person is physically transporting cash, bearer negotiable instruments, precious metals or precious stones including gold, silver, diamonds or sapphire.

6 Duty of authorised officer to ascertain purpose and intended use

Where a person makes a declaration under the *Proceeds of Crime (Border Declaration Form) Regulations 2023*, an authorised officer shall ascertain the

origin, purpose and intended use of the cash, bearer negotiable instrument, precious metals or precious stones including gold, silver, diamonds or sapphire.

7 Record of border declaration forms

- (1) The Nauru Customs Service shall keep and maintain a record of all declarations made for the purposes of Part 6 of the Act, for a period of 7 years from the date the declaration is made.
- (2) The declarations under subregulation (1) shall include:
 - (a) any border declaration form; or
 - (b) a declaration form noting an authorised officer's suspicion of the commission of any offence including a money laundering or terrorist related offence.
- (3) For the purpose of subregulation (1), '*Nauru Customs Service*' has the meaning given to it under Section 4 of the *Customs Act 2014*.

8 Reporting of suspicion of money laundering or terrorist financing offence

Where an authorised officer notes under Regulation 7, the suspicion of the commission of an offence including a money laundering or terrorist related offence, the authorised officer shall immediately report the matter to the Financial Intelligence Unit or the Nauru Police Force.

9 Confidentiality

A person who processes or receives information in accordance with these Regulations shall regard the information as confidential and not disclose it unless required by law.

10 Regulations not to affect trade payment or capital movement

The Financial Intelligence Unit, Customs officer or any other competent authority shall ensure that the enforcement of these Regulations does not affect:

- (a) a trade payment between the Republic and other countries, for goods and services; or
- (b) the freedom of movement of capital in any way, in and out of the Republic.

11 Forfeiture order where person is untraceable or unknown

For the purpose of Section 21(2) of the Act, the following category of persons, may also be considered by the Court, against which a forfeiture order may be issued:

- (a) a person who cannot be traced or his or her whereabouts is unknown; or
- (b) the person is not known.

The Cabinet makes the following Regulations under Section 109 of the *Proceeds of Crime Act 2004*:

1 Citation

These Regulations may be cited as the *Proceeds of Crime (Management and Disposal of Property) Regulations 2024*.

2 Commencement

These Regulations commence on the date they are notified in the Gazette.

3 Interpretation

In these Regulations:

‘*Act*’ means the *Proceeds of Crime Act 2004*;

‘*Administrator*’ has the same meaning given under the Act;

‘*competent authority*’ means a person who is authorised under a written law to enforce a restraining order;

‘*Confiscated Assets Fund*’ means the fund established under Section 100 of the Act;

‘*designated person or entity*’ has the meaning given under the *Anti-Money Laundering and Targeted Financial Sanctions Act 2023*;

‘*financial institution*’ has the meaning given to it under the *Anti-Money Laundering and Targeted Financial Sanctions Act 2023*;

‘*foreign competent authority*’ means a person who is authorised under the law of another country to enforce a seizure, freezing, restraining, confiscation or forfeiture order;

‘*foreign restraining order*’ means an order made by a court of another country authorising a foreign competent authority of that country to restrain property;

‘*law enforcement authority*’ means any person or body vested with a function and power to enforce written laws pertaining to anti-money laundering and counter terrorism in addition to the Nauru Police Force;

‘*possession, power and control*’ includes taking into custody and control of a property as required under the Act;

‘*reporting entity*’ has the meaning given to it under the *Anti-Money Laundering and Targeted Financial Sanctions Act 2023*;

‘*supervisory authority*’ has the meaning given to it under the *Anti-Money Laundering and Targeted Financial Sanctions Act 2023*; and

‘*UNSC*’ means the United Nations Security Council or its committees.

4 Functions, responsibilities, duties and obligations of the Administrator

The functions, responsibilities, duties and obligations of the Administrator in respect of any seized or restrained property until its title is determined, sold or disposed of, are as follows:

- (a) to coordinate with the authorities which identify and trace property that is subject to seizure, forfeiture or confiscation;
- (b) to coordinate with all supervisory authorities, departments, statutory bodies and other relevant institutions which deal with properties seized, frozen, restrained, confiscated or forfeited to the Republic under any written law;
- (c) take possession, power and control of the property in accordance with any written law;
- (d) take reasonable steps to ensure to maintain, preserve, store and manage the property;
- (e) maintain the property in accordance with the requirements of that specific property;
- (f) return the property to the person from whom it was seized or to a person who owns it where the title to the property is finally determined by a court or competent authority;
- (g) where required to, appoint such other persons to assist in the controlling and management of such property;
- (h) take steps for filing appropriate applications before the court for freezing or seizing property to prevent dealing with, transferring or disposal of such property;
- (i) take necessary action to prevent a person from taking steps to freeze, seize or recover the property from the Republic;
- (j) assist law enforcement authorities in taking appropriate investigation measures to identify and preserve property for exhibit, evidence or to be used in any investigation or proceeding;
- (k) assist the identification and tracing of property that is subject to confiscation or forfeiture;
- (l) assist in by taking possession, power or control of a property to prevent the transfer or disposal of the property as an interim measure;
- (m) establish, keep and maintain records of the property that comes under the possession, power, control and management of the Administrator;
- (n) take steps for the disposal of property through public tender or auction;
- (o) identify and make arrangements with such persons or bodies for the purposes of the preservation, management or maintenance of such property;
- (p) assist law enforcement authorities to implement a coordinated mechanism for disposal of property;
- (q) assist the Minister, Financial Intelligence Unit, Nauru Police Force or any other law enforcement authority in coordinating with a similar person or body as the Administrator of other countries in freezing, seizure or forfeiture of property whether there is a reciprocal arrangement or not;
- (r) protect rights of *bona fide* third parties;
- (s) transport property from one location to another for the purposes of preservation, storage, maintenance, valuation, auctioning or for sale;
- (t) repair or maintain any property for the purposes of any transportation or to maintain the property in good working condition;
- (u) engage any third party, expert or specialist for carrying out inspection, maintenance, valuation, marketing and any other related activities for a property;
- (v) where required to, engage professional or appropriately qualified or experienced persons for the purposes of operating a commercial business or

- the leasing and rental of property for investment purposes until the title to the property is determined or is ordered to be disposed of;
- (w) issue policies, procedures and guidelines on tracing, locating, seizing, taking into possession, control, sale, disposal, management of property and other related matters relevant to a specific property;
 - (x) keep records of the activities he or she undertakes in respect of each property separately including any expenses incurred for the preservation, management and for procuring any sale of the property; and
 - (y) undertake all such other measures that may be required from time to time in carrying out his or her functions, responsibilities, duties and obligations.

5 Properties which the Administrator takes control of

The following categories of property may become subject of a restraining order or are required to be frozen, preserved or managed by virtue of the operations of law or international obligations:

- (a) property detained under a search warrant pursuant to an order of the court or where a request is made by the Commissioner of Police for the preservation of the property for the purposes of investigation or proceedings;
- (b) property including currency or funds confiscated or detained by any other law enforcement authority other than the Police for any purpose including for investigation and preservation;
- (c) property under an order of a foreign court or on a request by a foreign competent authority;
- (d) property subject to a freezing order by virtue the United Nations Security Council Resolutions;
- (e) funds which are capable of being confiscated and deposited in the Confiscation Assets Fund including:
 - (i) any funds seized by a customs officer or authorised officer being imported into or exported from the Republic;
 - (ii) any funds detained or frozen by operators of gaming machines; or
 - (iii) any funds detained or frozen by reporting entities; and
- (f) local or foreign currency, bearer negotiable instrument or precious metals or stones including gold, silver, diamonds or sapphire seized by a customs officer or authorised officer which is imported into or exported from the Republic by a person or in his or her hand carried, checked in luggage, unaccompanied luggage, cargo or mail.

6 Detaining tainted property under warrant by police

- (1) The Commissioner of Police is vested with the power to seize and detain a property under a warrant pursuant to Section 36A of the Act.
- (2) The Director of Public Prosecution shall make an application to the court for a restraining order of any property seized and detained under subregulation (1), within 7 days of the execution of the warrant.
- (3) Subject to subregulations (4) and (5), a property which is seized and detained under subregulation (1) shall not become property over which the Administrator may take custody or control where the property is detained by police for the purposes of criminal proceedings.

- (4) The court may make an order to preserve, store or manage a property under subregulation (1) until further order of the court or final determination of the title or ownership of the property.
- (5) Where the Commissioner of Police or any person authorised by him or her requests the Administrator to take possession, power or control of a property for the purposes of preserving, storing or managing until the completion of the investigation or a proceeding, it shall be deemed that the taking of possession, power or control of property by the Administrator shall not affect the admission of the property as evidence in court, cause or matter or any proceeding.

7 Seizure or detaining of property by other law enforcement authorities

- (1) The law enforcement authorities other than the police may seize and detain any property over which it has a power to seize and detain under any written law.
- (2) Where a property is seized and detained under subregulation (1), the law enforcement authority shall report in Form 1 of the Schedule the seizure and detention of the property to the Director of Public Prosecutions within 7 days of the seizure and detention, where there has been no claim made.
- (3) The Director of Public Prosecution shall make an application to the court for a restraining order of any property seized or detained under subregulation (1), within 7 days of notification to him or her.
- (4) The court may make an order to preserve, store or manage a property under subregulation (1) until further order of the court or final determination of the title to the property.

8 Seizure of currency or cash

- (1) Where a police officer or a law enforcement officer seizes any currency or cash, he or she shall:
 - (a) count the currency or cash in the presence of the person from whom the currency or cash is seized;
 - (b) record the amount of the currency or cash;
 - (c) provide an inventory in Form 2 of the Schedule to the persons from whom the currency or cash was seized;
 - (d) secure the safety of the currency or cash; and
 - (e) deposit the currency or cash into the Confiscated Assets Fund and inform the Secretary for Finance and Administrator.
- (2) Where necessary the Director of Public Prosecutions may make an application to the court for a restraining order for the safe and secure custody of the currency or cash to be deposited into the Confiscated Assets Fund.

9 UNSC freezing of property or funds

- (1) Where the UNSC resolution is made as part of targeted financial sanctions for the freezing of any property or funds, any person or entity having possession, power or control of such property or funds in the Republic shall freeze such property or funds.

- (2) The person or entity which freezes any property or funds under subregulation (1) shall immediately inform in Form 3 of the Schedule, the Supervisor of the Financial Intelligence Unit and the Administrator of such freezing.
- (3) Notwithstanding subregulation (2), the Supervisor of the Financial Intelligence Unit shall inform the Administrator of the property or funds and the location of such property or funds under this Regulation.

10 Procedure for the Administrator to take custody and control of property and funds

- (1) A supervisory authority, department, statutory body, Nauru Police Force or any other law enforcement authority upon seizing or restraining any property or fund, shall provide the information in Form 4 of the Schedule of such property to the Administrator within 7 days:
 - (a) of the seizing or restraining of such property; or
 - (b) from the date the court makes the order.
- (2) The Administrator shall require the persons who have any possession, power and control of property under subregulation (1) to provide access to the Administrator to the restrained property.
- (3) The Administrator shall take an inventory of all such properties in Form 5 of the Schedule and provide a copy of the Form to the person in subregulations (1) and (2).
- (4) The persons who have possession, power and control of property or funds in Form 6 of the Schedule which are restrained or frozen and is demanded by the Administrator to be transferred or delivered shall:
 - (a) transfer or deliver or permit the Administrator to have the property transferred or delivered to a location provided by the Administrator; and
 - (b) pay any funds restrained or frozen into the Confiscated Assets Fund.

11 Property under the possession, power, control and management of Administrator

- (1) The Administrator shall have the general management of the property that is subject to a restraining order.
- (2) Where the Administrator has taken possession, power, control and management of a property, he or she shall ensure that the restrained property is preserved, stored and managed in accordance with an order of the court or any other written law.

12 Restrained funds in any reporting entity

- (1) A financial institution or any reporting entity which holds any funds that are restrained under an order of the court, Act or any other written law, shall on demand by the Administrator or as ordered by the court, shall pay such fund into the Confiscated Assets Fund.
- (2) The restrained funds shall remain in the Confiscated Assets Fund until such time any proceedings commenced relating to the funds are completed or an order or direction given by the court.

13 Administrator may in certain circumstances invest restrained property or funds

- (1) The funds may be invested by the Administrator for the purposes of raising revenue for the distribution of funds from the Confiscated Assets Fund as provided under the Act.
- (2) Any returns or income derived from the investment in subregulation (1) shall be paid into the Confiscated Assets Fund.

14 Administrator to ensure funds are to be deposited into the Confiscated Assets Fund

In addition to the monies deposited in the Confiscated Assets Fund under Section 100 of the Act, the following funds shall be deposited into the Confiscated Assets Fund:

- (a) funds which are restrained under these Regulations;
- (b) income from any business or property managed by the Administrator;
- (c) any profits gained on the sale of any properties;
- (d) proceeds of the forfeited properties; and
- (e) funds payable or reimbursable to the Republic under the Act.

15 Secretary for Finance to provide access of Confiscated Assets Fund to Administrator

The Secretary for Finance shall provide access to the Administrator to the Confiscated Assets Fund for the purposes of:

- (a) reporting any matters relating to any specific persons or entities' funds held in the Confiscated Assets Fund;
- (b) providing monthly report to the Minister;
- (c) provide constant updates on the account as and when required by the Supervisor of the Financial Intelligence Unit;
- (d) providing information in any court or any other proceeding at the request of any party to such proceedings, subject to the requirements of the laws relating to disclosure of information for that purpose; and
- (e) any other lawful or justifiable reason which the Administrator may deem fit.

16 Disposal of deteriorating or undesirable property

- (1) The Administrator may make an application in Form 7 of the Schedule to the court for an order for the destruction of any seized or restrained property which is deteriorating or is undesirable.
- (2) The court may issue an order for the:
 - (a) destruction of a property, where it is not in the public interest to preserve or store such property;
 - (b) destruction of property that is likely to be used to commit a further crime or unlawful activity;
 - (c) destruction of any property that is illegal to possess, own or use;
 - (d) destruction of counterfeit property;
 - (e) destruction of a property which is a threat to public safety or the environment;
 - (f) manner in which such property is to be destroyed; and
 - (g) such other directions as the court deems fit and just.

- (3) The court may order or direct the appointment of skilled professionals to be engaged for the purposes of destroying property.

17 Sale of deteriorating property

- (1) The Administrator may make an application in Form 8 of the Schedule to the court for an order that a property which is seized or restrained, be sold.
- (2) The court may grant an order for property to be sold where the:
 - (a) expenses relating to the preservation, management, or controlling the property exceeds the value of the property;
 - (b) property is being wasted or loses its value if it is restrained;
 - (c) value of the property may not be wasted or lost but other costs on the property may continue to escalate due to mortgage, charge, breach of contractual services and such other matters which would result in the realisable value of the property being negated;
 - (d) property which is perishable;
 - (e) property which is easily replaceable or its replacement value can be easily ascertained; and
 - (f) court may deem it fit and just to grant the order in any other circumstance,until the final decision is made by the court or any competent authority in respect of such property.

18 Valuation of property

- (1) The Administrator shall have the power in respect of any seized or restrained property to:
 - (a) appoint an appropriately qualified person to value such property; and
 - (b) arrange for an inventory to be taken of any chattels including fittings, stock in trade, motor vehicles, machines and other similar equipment normally used in the trade or profession.
- (2) The Administrator may provide the information collated or ascertained in subregulation (1) to any authorised person including all those parties or persons to whom the seizure warrant or the restraining order was ordered by the court to be served.

19 Sale of forfeited property

- (1) The Administrator may sell a forfeited property.
- (2) The Administrator shall ensure that the sale of the property is undertaken in an objective manner and obtain the best price which is reasonably obtainable having regard to the circumstances of the property in which it is sold.
- (3) The funds obtained from the sale of the property is to be deposited into the Confiscated Assets Fund.
- (4) Where necessary, the Administrator may invite tenders or bids for the sale of any property outside the Republic or any other specific foreign jurisdiction in order to comply with the requirements of subregulation (2).
- (5) For avoidance of any doubt, the Administrator shall not be prevented from selling a property at a price lower than the reasonable market price in subregulation (2), where such price is unascertainable after having:

- (a) taken reasonable steps to obtain the best possible price;
- (b) sought expert price on market value of the property; and
- (c) obtained independent valuation.

20 Sale by tender, bids or other competitive manner

- (1) Where a property is sold by a tender, bid or any other open competitive process, the Administrator shall follow the following rules:
 - (a) where 2 or more tenders or bids received are in the same amount, the first tender or bid received shall be given precedence;
 - (b) the Administrator shall inform the person in writing whose tender or bid has been accepted;
 - (c) the Administrator shall provide a specific time frame by which the tenderer or bidder is to respond to the acceptance of the offer and pay the deposit and full price offered by him or her;
 - (d) where a tenderer or bidder fails to complete the requirements in paragraph (c), the Administrator shall cancel that sale and accept the next best acceptable tender or bid; and
 - (e) where the tender or bid is accepted and the tenderer or bidder complies with all the requirements, the Administrator shall complete the sale in accordance with the requirements for the sale of that particular property.

21 Net proceeds to be deposited in Confiscated Assets Fund

- (1) The net proceeds of the sale of any property, which is forfeited may be used for such purpose provided for under the Act.
- (2) The net proceeds shall be ascertained after the deduction of the following expenses and costs from the proceeds of the sale shall be paid in the following order:
 - (a) monies which has been provided by the Republic to the Administrator for the purposes of tracing, investigating or managing such property;
 - (b) costs and expenses incurred for taking into possession, power, control, freezing and managing and for the sale of the property;
 - (c) payment of costs or damages to any parties to the proceedings as ordered by the court;
 - (d) any lawful debts or monies owed under a registerable security to an innocent third party;
 - (e) payment of any other levies, rates, penalties, fines and similar liabilities incurred under any written law; and
 - (f) balance to remain in the Confiscated Assets Fund to be used in accordance with the provisions of the Act.

22 Administrator may manage foreign restrained property

- (1) The Administrator shall have the power to enter into any agreement or arrangement for the purposes of taking power, control and management of restrained property subject to a foreign restraining order.
- (2) The Administrator in performing any functions, duties, responsibilities or obligations he or she may enter into an agreement with a foreign competent authority or person named in the order of the court of a foreign jurisdiction.

- (3) The Administrator shall perform all such functions, duties, responsibilities or obligations and exercise all such powers he or she has under the Act or any other written law in respect of preserving, storing and management under these Regulations, as if the property was subject to a domestic freezing or restraining order or arrangement.
- (4) Where the order of a court of a foreign jurisdiction is required to be registered under the *Foreign Judgments (Reciprocal Enforcement) Act 1973* as an order of the Supreme Court of Nauru, the foreign competent authority shall ensure that the requirements are complied with before entering into an agreement or arrangement with the Administrator under subregulation (1).

23 Access to property or funds prohibited to designated persons or entities

The Administrator shall take all necessary steps to prevent the availability of property or funds to designated persons or entities except where the request is made in accordance with the *Anti-Money Laundering and Targeted Financial Sanctions (Terrorist Financing and Proliferation Financing) Regulations 2023*.

24 Obstruction of the Administrator

- (1) A person shall not obstruct, hinder or fail to cooperate with the Administrator in the lawful performance of his or her functions or exercise of his or her powers under these Regulations.
- (2) A person who contravenes subregulation (1) commits an offence and shall be liable upon conviction to a fine not exceeding \$10,000 or an imprisonment term not exceeding 6 months or both.

25 Consent Orders

- (1) The parties in any cause or matter in any court may enter into an agreement and the court may grant an order by consent of all the parties.
- (2) A consent order in respect of a property shall not be set aside once it is granted.
- (3) The Administrator shall ensure that a consent order in respect of the properties to which he or she has possession, power, control and management complies with the requirements of the Act and shall not permit the removal, dissipation, destruction or sale of any offending property or subject to a pending proceeding in court.

26 Proceedings against body corporate

- (1) Where a body corporate commits an offence against these Regulations and it is proved that the offence occurred with the knowledge and consent of an officer of the body corporate, or a person purporting to act as an officer of the body corporate, that person, as well as the body corporate, commits the offence.
- (2) Where the affairs of a body corporate are managed by its members, subregulation (1) applies in relation to the acts and defaults of a member in connection with the member's functions of management as if the member were an officer of the body corporate.

- (3) Where in proceedings under these Regulations it is necessary to establish the state of mind of a body corporate in relation to particular conduct, it is sufficient to show that:
 - (a) the conduct was engaged in by an officer of the body corporate within the scope of his or her actual or apparent authority; and
 - (b) the officer had that state of mind.
- (4) Where an officer of a body corporate engages in conduct on behalf of the body corporate within the scope of his or her actual authority, for the purposes of proceedings under these Regulations, the body corporate is taken also to have engaged in the conduct unless the body corporate establishes that it took reasonable precautions and exercised due diligence to avoid the conduct.

27 Effect of person's death during the period property under the care of Administrator

- (1) A reference in these Regulations to property of a person includes a reference to the property of a deceased person where the property was owned or effectively controlled by the person immediately before his or her death or given away by the person at any time before his or her death.
- (2) An order may be applied for and made under these Regulations:
 - (a) in respect of property that is or was owned or effectively controlled or given away by a person who died before the application or order is made; and
 - (b) on the basis of the activities of a person who died before the application or order is made.
- (3) Where a person who owns property that is subject to a restraining order dies, these Regulations continue to apply to the property in all respects as if the person had not died, regardless of whether the administrator of the person's estate or any other person in whom the property vests as a result of the death is an innocent party in relation to the property.
- (4) Without limiting this regulation, where a person who is a joint tenant of property that is subject to a restraining order dies, the:
 - (a) person's death does not operate to vest the property in the surviving joint tenant or tenants; and
 - (b) restraining order continues to apply to the property as if the person had not died.

28 Record keeping obligations of the Administrator

- (1) The Administrator shall keep and maintain a record of all matters required to be kept and maintained in relation to property which the Administrator is required to take possession, power, control or management of under these Regulations.
- (2) The records shall be kept and maintained in:
 - (a) electronic or digital form; and
 - (b) physical form or in the case of electronic or digital form, capable of being produced in printed form.
- (3) The Administrator shall keep and maintain the records for a period of 7 years from the time all matters relating to the property, over which the

Administrator had possession, power, control or management, is disposed of and all funds relating to the property is appropriately accounted for.

29 Record keeping obligations of person or entity which had property

A person or entity which had in its possession, power or control, a property or fund to which a freezing or restraining order is made or is subject to these Regulations, he or she shall keep and maintain records:

- (a) of the property and relevant documents, instruments or any related matter; and
- (b) for a period of 7 years from the time he or she gave possession of the property to the Administrator or the Police under a warrant or to any law enforcement authority.

30 Confidentiality of information

- (1) Subject to subregulation (2), the Administrator shall keep and maintain the confidentiality of information required to be kept and maintained under this Act.
- (2) The Administrator, shall disclose such information for the purposes of:
 - (a) detecting, investigating or prosecuting an offence under this Act or any other written law;
 - (b) detecting, investigating or prosecuting an offence under the law of another country; and
 - (c) enforcing or taking action under this Act, any other written law or a law of another country relating to proceeds of crime.

31 Sharing, disclosure and exchange of information

For the purposes of Regulation 30(2), the Administrator:

- (a) whether on his or her own initiative or upon request, shall share, disclose or exchange information that is required to be kept and maintained under Regulation 28, to the Nauru Police Force, Financial Intelligence Unit or any other law enforcement authority;
- (b) may coordinate the exchange of information required to be kept and maintained under Regulation 28 with:
 - (i) a national law enforcement agency or authority;
 - (ii) an international law enforcement agency or authority; or
 - (iii) a regional or international body with a law enforcement function; or
- (c) share, disclose or exchange information required to be kept and maintained under Regulation 28, with a foreign body or entity with similar functions, responsibilities, powers and obligations as the Administrator, as he or she deems necessary.

32 Restriction on sharing, disclosure and exchange of information

Notwithstanding Regulation 31, the Administrator shall not disclose, share or exchange information, where the Administrator is not satisfied that the recipient of such information has in place, an adequate mechanism to keep such information confidential.

33 Proceedings against body corporate

- (1) Where a body corporate commits an offence against these Regulations and it is proved that the offence occurred with the knowledge and consent of an officer of the body corporate, or a person purporting to act as an officer of the body corporate, that person, as well as the body corporate, commits the offence.
- (2) Where the affairs of a body corporate are managed by its members, subregulation (1) applies in relation to the acts and defaults of a member in connection with the member's functions of management as if the member were an officer of the body corporate.
- (3) Where in proceedings under these Regulations it is necessary to establish the state of mind of a body corporate in relation to particular conduct, it is sufficient to show that:
 - (a) the conduct was engaged in by an officer of the body corporate within the scope of his or her actual or apparent authority; and
 - (b) the officer had that state of mind.
- (4) Where an officer of a body corporate engages in conduct on behalf of the body corporate within the scope of his or her actual authority, for the purposes of proceedings under these Regulations, the body corporate is taken also to have engaged in the conduct unless the body corporate establishes that it took reasonable precautions and exercised due diligence to avoid the conduct.

34 Annual report of the Confiscated Assets Fund

The Secretary for Finance and the Administrator shall jointly prepare an annual report of the activities of the Confiscated Assets Fund which shall be tabled in Parliament by the Minister by no later than 30th September of each financial year.

35 Administrator

In the absence of the appointment or presence of an Administrator, the Secretary for Justice shall be the Administrator, who shall have the functions, responsibilities, duties and obligations of the Administrator.

36 Application of the *Criminal Procedure Act 1972*

For the purposes of an investigation or a proceeding, the *Criminal Procedure Act 1972* shall *mutatis mutandis* apply.

37 Applications made in court

The Administrator, Director of Public Prosecutions or any other person who may be authorised to bring or defend a proceeding for the purposes of these Regulations, shall ensure that the applications are in compliance with the requirements of the *Criminal Procedure Act 1972* and the *Civil Procedure Rules* respectively, as they may appropriately apply to the nature of any such application or defence.
