## **6** Establishment of Corporation

- (1) There is hereby established a Corporation by the name of RONPHOS.
- (2) The Corporation:
  - (a) is a body corporate;
  - (b) has perpetual succession and a common seal;
  - (c) is capable of acquiring, holding and disposing of both real and personal property; and
  - (d) may sue or be sued in its corporate name.

(3) All courts, Judges and persons acting judicially shall take judicial notice of the seal of the Corporation affixed to a document and shall presume that it was duly affixed.

#### 7 Board of directors

- (1) The Corporation shall have a Board of directors appointed and holding office in accordance with the *Public Enterprises Act 2019*.
- (2) The business, operations and affairs of the Corporation shall be managed by, or under the direction or supervision of, the Board.

#### 7A Common seal and execution of documents

- (1) The common seal of the Corporation shall not be affixed to a document except in accordance with a decision of the Board, and the affixing of the seal shall be attested by the signature of the Chair or a person authorised under subsection (2).
- (2) The Corporation may, by instrument under its common seal, authorise a director, an employee whether nominated by name or by duties or position, or any other person to execute documents on behalf of the Corporation subject to conditions and limitations, if any, specified in the instrument.
- (3) Without limiting subsection (2), an authority may authorise 2 or more persons to execute documents jointly on behalf of the Corporation.
- (4) A document is duly executed by the Corporation if:
  - (a) the common seal of the Corporation is affixed to the document in accordance with this Section; or
  - (b) the document is signed on behalf of the Corporation by a person or persons in accordance with an authority conferred under this Section.

#### DIVISION 2 — OBJECTS AND POWERS OF THE CORPORATION

## 9 Objects of the Corporation

The objects of the Corporation are to:

- (a) maintain and operate the phosphate industry in the Republic in a safe, efficient and profitable manner;
- (b) establish, maintain and operate such activities as are, or may be ancillary to the maintenance and operation of the phosphate industry in the Republic;
   and
- (c) establish, maintain and operate such other activities that are included in the Corporation's business plan adopted by the Board in accordance with the *Public Enterprises Act 2019*.

## 10 Powers of the Corporation

(1) Subject to this Act and the *Public Enterprises Act 2019*, the Corporation has the power to do all things necessary, convenient or appropriate to be done, whether in the Republic or elsewhere, for the fulfillment of its objects.

- (2) Without limiting the generality of subsection (1), and subject to the provisions of this Act and any Regulations, the powers of the Corporation include the power to:
  - (a) enter into contracts in relation to any sale or disposal of phosphate or any other products of the Corporation;
  - (b) enter into contracts in relation to any service to be performed by the Corporation whether in connection with the sale of phosphate or other products or otherwise;
  - (c) purchase, lease, hire or otherwise acquire land, buildings, plant, machinery and any other capital assets;
  - (d) sell or dispose of any capital assets of the Corporation;
  - (e) appoint agents for the purpose of any business conducted by the Corporation and to terminate any such appointment;
  - (f) act as agent for other persons;
  - (g) surrender or return to the owners of land leased or acquired, but no longer required, for use in the phosphate industry;
  - (h) rehabilitate and develop lands, including through the removal of materials, scrap and structures used for the mining of phosphate, in line with environmental laws;
  - (i) compound, release or settle claims by or against the Corporation; and
  - (j) do anything incidental to any of its objects.

#### PART 3 — MISCELLANEOUS

## 27 Transitional

- (1) The Corporation is vested with ownership of all the assets owned and managed by the former Nauru Phosphate Corporation, including leases, concessions, contracts, real and personal property, equipment and intellectual property rights to the full extent of the previous ownership by Nauru Phosphate Corporation.
- (2) The Corporation shall be responsible for liabilities and debts incurred by the former Nauru Phosphate Corporation, except those debts that have been written off by the Cabinet and notified to the creditor or creditors concerned.
- (3) All persons previously employed by the former Nauru Phosphate Corporation shall initially be considered to be appointed as temporary employees of the Corporation, but otherwise on the terms of their former employment with the former Nauru Phosphate Corporation and with any accrued rights and entitlements due from their employment under the former Nauru Phosphate Corporation.
- (4) The Corporation may offer appointment in a full-time, part-time or an on-call basis, to such temporary employees referred to in subsection (3) as it deems necessary.
- (5) Those persons not offered appointment to the Corporation shall be relieved of their temporary employment, whilst retaining any outstanding rights and entitlements, as and at such times as the Corporation deems necessary to effect an efficient and restructured management and staff organisational structure.

# 28 Disclaimer of property

Upon the commencement of this Act the Executive Committee may within the 6 months following, disclaim any leasehold properties previously held by the Nauru Phosphate Corporation. Any leasehold property not so disclaimed shall remain an asset of the corporation and the corporation shall be liable for all of the obligations applicable thereto. If any leasehold property is disclaimed the Corporation may remove all fixtures and fittings erected or upon the land by the Nauru Phosphate Corporation or its predecessor in title the British Phosphate Commissioners, and upon completion of such removal the property shall revert to the owner thereof.

## 29 Damage or destruction of property

- (1) A person who removes, damages or otherwise interferes with any property of the Nauru Phosphate Corporation before the commencement of this Act or who does so after it becomes an asset of the Corporation or who attempts to prevent the removal of any fixtures or fittings in accordance with Section 28, commits an offence punishable by a fine of \$1,000 or 3 months imprisonment, or both.
- (2) Where a person is convicted of an offence against subsection (1) the Judge or magistrate may, in addition to the imposition of a penalty, order the

confiscation and sale of any property of the person convicted, including any interest in phosphate royalties payable now or in the future to the value of the property so removed, damaged or interfered with.

## 30 Regulations

The Cabinet may make regulations not inconsistent with this Act prescribing all matters necessary or convenient to be prescribed for carrying out or giving effect to this Act, and, in particular, prescribing penalties not exceeding \$1,000 or imprisonment for a period not exceeding 3 months, or both, for offences against the regulations.

## 31 Accrued royalties

- (1) The aggregate amounts owed by the Corporation to individual owners of phosphate land (landowners) in their respective capacity as a beneficiary of the Nauruan Landowners Royalty Trust Fund (Fund 2) (or owed to their legal representatives or lawful heirs) in respect of phosphate royalties accrued as owning in the respective financial years ending 30 June 2007 to 30 June 2014 (both inclusive) are deemed to be as enumerated in Schedule 4.
- (2) Cabinet may make regulations prescribing the payment by the Corporation of the accrued royalties enumerated in Schedule 4 to the respective individual owners of phosphate land to whom such accrued royalties remain payable (or owed to their legal representatives or lawful heirs).
- (3) Subject to any Cabinet regulations, in the financial quarter ending 30 September 2016 and in each subsequent financial quarter (period ending of three calendar months) until the total of all accrued royalties enumerated in Schedule 4 have been fully repaid to the respective individual owners of phosphate land to whom such accrued royalties were payable, the Corporation shall pay to the landowner to whom such accrued royalties remain payable (or to their legal representatives or lawful heirs), the amount of \$5.32 in respect of each ton of phosphate shipped from Nauru during the immediately preceding financial quarter and such payment to each of such landowner individually shall be made by the Corporation in the proportion that that the amount of such accrued royalties owing to each such landowner represents as a proportion of the total aggregate amount of such accrued royalties owing to all such landowners collectively, without any preference in favour of any individual landowner(s).
- (4) To give full effect to subsection (3), the Corporation shall make provision for the payments provided for in subsection (3) in the Corporation's planned operations and estimates to be prepared pursuant to Section 21(1) in respect of the financial year ending 30 June 2017 and in respect of each subsequent financial year up to and including the financial year in which the balance of all of the accrued royalties enumerated in Schedule 4 shall have been fully repaid.
