#### AN ACT

#### To amend the Schedule to the Licences Act 1922-1978

(Certified: 13/6/97 )

#### Enacted by the Parliament of Nauru as follows:

#### SHORT TITLE

1. (1) This Act may be cited as the Licences (Amendment) Act 1997.

(2) The Licences Act 1922-1978 as amended by this Act may be cited as the Licences Act 1922-1997.

#### COMMENCEMENT

2. This Act shall come into force with immediate effect.

# **REPLACEMENT OF THE SCHEDULE TO THE LICENCES ACT 1922-**1978

3. The Schedule to the Licences Act 1922-1978 is repealed and replaced with the following new Schedule, namely:-

#### LICENCES (AMENDMENT) BILL 1997

#### **OBJECTS AND REASONS**

THE FEES FOR DIFFERENT KINDS OF LICENCES WERE LAST FIXED BY THE SCHEDULE TO THE LICENCES (AMENDMENT) ACT 1922-1978 WHICH PRESENTLY READS AS UNDER:-

### EXISTING SCHEDULE

SINCE THEN (1978) ADMINISTRATIVE COST FOR PROCESSING LICENCE APPLICATIONS HAS CONSIDERABLY INCREASED AND IT IS FELT THAT IT SHOULD HAVE AN IMPACT ON THE QUESTION OF ENHANCING EXISTING LICENCE FEES. FURTHER IT IS A MATTER OF COMMON KNOWLEDGE THAT THE PRICES OF DIFFERENT COMMODITIES, PARTICULARLY ESSENTIAL COMMODITIES, HAVE INCREASED AND CONSEQUENTIALLY THE MARGIN OF PROFIT OF THE TRADERS HAS ALSO INCREASED. THE FEE FOR INCREASE OF TRADING LICENCE IN ITEM I (ONE) IS THEREFORE FULLY JUSTIFIED. FURTHER IN THE CASE OF EXPLOSIVES ALSO IT SEEMS TO BE EXPEDIENT THAT THE FEE SHOULD BE INCREASED IN ITEM 2 (TWO) OF THE EXISTING SCHEDULE.

THE EXISTENCE OF THE FEE AT ITEM 3 (THREE) FOR OWNING OR BEING IN POSSESSION OF DOGS IN EXISTING SCHEDULE IS ANOMALOUS FOR REASONS AS STATED HEREINAFTER.

BY SECTION 21 OF THE ANIMALS ACT 1982 (NO.6 OF 1982) ITEM 5 IN THE SCHEDULE TO LICENCES ORDINANCE <u>1922-1967</u>, WHICH LAID DOWN THE FEES FOR SUCH MATTERS, WAS REPEALED.

THUS IN 1982 THE SAID ITEM 5 WAS NOT IN EXISTENCE IN AMENDED LICENCES ORDINANCE <u>1922-1978</u>, BUT IT WAS SHOWN AS ITEM 3.

THIS APPARENTLY OCCURRED BY INADVERTENCE AND OPPORTUNITY CAN BE AVAILED TO RECTIFY THIS SITUATION IN THE PRESENT AMENDMENT BILL BY NOT INCLUDING THESE ITEMS IN THE NEW SCHEDULE.

AS IT IS THIS MATTER IS BEING COVERED BY THE ANIMALS (PRESCRIBED FEES) REGULATIONS 1996 MADE UNDER SECTION 20 OF THE ANIMALS ACT 1982 AND IS BEING LAID BEFORE THE PARLIAMENT DURING THE CURRENT 1997 SESSIONS, THEREFORE THE ITEM RELATING TO THE FEE FOR OWNING OR BEING IN POSSESSION OF DOGS SHOULD NOT FIND PLACE IN THE SCHEDULE TO THE PRINCIPAL ACT, NAMELY, THE LICENCES ACT 1922-1978 AND WOULD AUTOMATICALLY STAND REPEALED.

ACCORDINGLY IT IS PROPOSED TO REPEAL THE EXISTING SCHEDULE AND SUBSTITUTE IT BY A NEW SCHEDULE AS BELOW.
