# **Laws Repeal and Adopting Act 1922**

# As in force from 15 April 2011

This compilation comprises Ordinance No. 8 of 1922 as amended and in force from 15 April 2011 (being, at the time the compilation was prepared on 9 May 2011, the date of commencement of the most recent amendment).

The notes section at the end of the compilation includes a reference to the law by which each amendment was made. The Table of Amendments in the notes section sets out the legislative history of individual provisions. The Historical Table of Adopted Laws in the notes section provides a full account of the laws adopted under this Act throughout its currency.

The operation of amendments that have been incorporated in the text of the compilation may be affected by application provisions that are set out in the notes section at the end of the compilation.

This compilation is prepared and published in a legislation database by the Nauru Parliamentary Counsel under the *Legislation Publication Act 2011*.

# Laws Repeal and Adopting Act 1922

An Act to adopt certain laws of the Commonwealth of Australia, Queensland and the former Territory of Papua as laws of Nauru

#### 1 Short title

This Act may be cited as the Laws Repeal and Adopting Act 1922.

### 10 Application of certain Commonwealth laws

Subject to this Act, the Acts of Parliament of the Commonwealth of Australia specified in Schedule 1 shall, so far as they are applicable, apply to Nauru.

### 12 Adopting Statutes of Queensland

Those portions of the Acts and Statutes of the State of Queensland specified in Schedule 2 and any amendments thereto that were in force in the said State on 1 July 1921, and those portions of every regulation or rule made under the provisions of any of the said Acts or Statutes that were in force at the date aforesaid are hereby adopted as laws of Nauru, so far as the same are applicable to the circumstances of Nauru, and are not repugnant to, or inconsistent with the provisions of any Act, Ordinance, law, regulation, rule, order, or proclamation having the force of law, that has been, or may hereafter be expressed to extend to, or applied to, or made or promulgated in Nauru.

### 14 Adopting Ordinances of Papua

Those portions of the Ordinances of the former Territory of Papua specified in Schedule 3 that were in force in that Territory on 23 September 1922, and those portions of every regulation or rule made under the provisions of any of the Ordinances that were in force in that Territory on 23 September 1922 are adopted as Ordinances, regulations, and rules of Nauru so far as the same are applicable to the circumstances of Nauru, and are not repugnant to, or inconsistent with the provisions of any Act, Ordinance, law, regulation, rule, order, or proclamation having the force of law, that has been or may hereafter be expressed to extend to, or applied to or made or promulgated in Nauru.

# 16 Adopted law to be construed to meet circumstances of the Island

All or any references to authorities, persons, places, subjects, matters, or things in any Act, Statute, law, regulation, or rule hereby adopted shall be taken as referring to corresponding or analogous authorities, persons, places, subjects, matters, or things in Nauru, and for the purpose of facilitating the application of any of the aforesaid Acts, Statutes, laws, regulations, or rules hereby adopted, it shall be lawful for any Court or magistrate to construe the same with such verbal alteration not affecting the substance as may be necessary to render the same applicable to the matter before the Court or magistrate.
