SUPPLEMENTARY APPROPRIATION 2012-13

OVERVIEW

The Supplementary Appropriation Bill (No. 2) 2012-13 makes a number of adjustments to the 2012-13 Budget estimates of expenditure to provide for events which were unanticipated at the time the 2012-13 Budget and which arose subsequent to the Supplementary Appropriation Act (No. 1) 2012-13. This statement also identifies a number of additional revenues.

The total expenditure in this Supplementary Budget amounts to \$1,446,888. Most of this additional expenditure is accounted for under four items:

- \$795,428 for Department of Justice and Judiciary requiring increased capacity to fulfil new RPC obligations;
- \$686,122 for debt repayment to AusAID, paying borrowed AusAID project funds in 2011, which were used to assist procurement of much needed fuel for the island;
- \$300,000 for a loan to Eigigu Holding Corporation; and
- \$191,420 to cover for increased electricity costs across a number of departments.

Revenues are also forecast to increase by \$870,000 with the largest item of \$500,000 being for a 2011-12 AusAID Performance Linked Aid (PLA), that was received in the AusAID account in June 2012, but was only transferred to the Treasury account in 2012-13 financial year.

The original 2012-13 Budget provided for a small surplus of \$25,842. As a result of the Supplementary Appropriation Act (No. 1) 2012, the surplus rose to \$2.9 million. Now, as a result of the Supplementary Appropriation Bill (No. 2) 2012-13, the surplus is reduced to \$2.4 million. Details are in Table 1.

Head 03 - Chief Secretary Secretariat - Blue Ocean Workshop

The Government agreed to conduct the Blue Ocean Strategy Workshop for senior Government and State Owned Enterprise (SOE) officials. The workshop was successfully delivered by expert presenters' on-island in October this year.

Head 12 - Public Debts - SPC Outstanding Membership

The Government has agreed to a repayment plan for outstanding membership balance which accrued in the previous years when Nauru was in a difficult financial situation. SPC has supported Nauru in a number of sectors through technical assistance and direct project grant thought the Government systems.

Head 15 - Nauru Revenue Office - New Vehicle & Stationeries

The Government has allocated an additional \$7,500 for a new vehicle for the Nauru Revenue Office (NRO). It is important that the NRO have a reliable vehicle to undertake its functions. These include the carrying of cash from major retailers in Nauru, undertaking mandatory enforcement work (such as with Bingo Licences) as well as future possible increased transport needs resulting from any new revenue measures the Government may introduce.

A further \$5,500 will cover costs of NRO stationeries, including for secure bags that are required for export of mute notes, spare parts for the driver's license machine, including toners and blank ID cards. The work of processing of drivers licenses was only recently transferred to NRO, and its costs were unanticipated during the 2012-13 budget process.

Head 16 - Finance Other - Eigigu Loan

The Government has allocated \$300,000 for the purpose of providing a loan to Eigigu Holdings Corporation (EHC). The purpose of the loan is to assist EHC with their venture with Australian Modular Homes to construct 70 new units to provide accommodation for expatriate workers at the Regional processing Centre. Under the contract EHC has agreed to repay the loan in six

equal payments of \$50,000 commencing January 2013 with the last payment before end June 2013 (see corresponding revenue item below).

Head 21 - Department of Commerce, Industry & Environment - Travel

In 2011-12, the Department of CIE was required to send representation to an important Climate Change meeting at the IRENA. The travel request was unforseen and was therefore not budgeted in the 2011-12 financial year. The travel cost remained outstanding with a travel agent and was only settled utilising 2012-13 budget funding in July 2012. This is now affecting the Department's 2012-13 approved travel plans. A total of \$7,500 is required to add back the funds to ensure that the Department continues with its current year travel commitments.

Head 43- Justice & Border Control - additional funding

The Department of Justice and Border Control is seeking to create new legal and other positions in the Department to assist in managing all of the new functions envisaged by processing refugee status determinations and general increase in workload across all areas of the Department generated by the opening of the RPC. A total of \$675,575 is required to fund the increased operations of the Department of Justice and Border Control.

Head 44 – Judiciary – additional funding

Judiciary is required to add capacity to meet the expected increase in activity in the courts, primarily due to the establishment of RPC on island. In this regard, Judiciary will be requiring additional funding of \$119,853 across various accounts.

The Department of Sports has recently made changes to the structure of the Australian Sports Commission funded EK Sports Project staff. All the EK project staff were recently put on contract, and as such, required necessary payout of entitlements for the EK staff who were previously employed under EK funding but as Public Servants. A total funding of \$1,540 is now budgeted for this payment.

Head 95 – Department of Telecommunication – Scoping and Design of ICT Relocation

The Government has agreed to the proposal to relocate the Department of Telecommunications and the ICT unit. The old RONTEL site has been identified for this purpose. At this stage, funding of \$30,000 is provided to undertake scoping and design work for the relocation.

The Government has allocated an additional \$191,420 for electricity for a number of departments to cover higher charges resulting from the installation by Utilities of pre-paid electricity meters at the Civic Centre. This has resulted in a significant increase in electricity charges for all Government departments located at the centre.
