ISSUANCE OF COMMISSION OF INQUIRY
TO REVIEW THE NAURUAN BASIC WAGE
REGIMEN

It is notified for general information that pursuant to section 3 of the Commission of Inquiry Ordinance 1961-1979, the Cabinet at its meeting held on the 6th of February 1987 altered a Cabinet decision dated 19th December 1986 and -

- (1) Reissued a Commission of Inquiry to review the Regimen of Nauruan Basic Wage with a view to establishing and recommending a new Basic Wage regimen with reference to which the Nauruan Basic Wage may be determined from time to time under section 27, subsection (2) of the Public Service Act 1961-1979 ;
- (2) Appointed Mr Ken Walker as the sole Commissioner charged with the above Commission;
- (3) Appointed Mr T.R. Ananthakrishnan, Chief Accountant, to be the Secretary to the Commission ;
- (4) Empowered the Commission to hear and/or receive representations, orally or written, from any persons ;
- (5) Empowered the Commissioner to examine evidence, documents or information as may be relevant to his task ;
- (6) Authorised the Commission to submit its report, as soon as it is able to complete its task ;
- (7) Authorised Commission to seek any consultancy assistance as may be required in fulfilment of its task; and
