THE CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY

BUSINESS OF GOVERNMENT

(ARTICLE 23)

IN EXERCISE of the powers in that behalf vested in me under Article 23 of the Constitution of Nauru, I, BERNARD DOWIYOGO, President of the Republic of Nauru, HEREBY ASSIGN to the Minister of Cabinet of Nauru as set out below, the responsibilities for the business of the Government of Nauru as set out opposite his name:-

MINISTER OF CABINET

His Excellency the President

BUSINESS OF GOVERNMENT

The Portfolio of the Minister for Island Development and Industry in relation to the business of Government to be undertaken in Nauru by the said Minister.

The Assignment of the business of the Government of Nauru as set out above is in addition to and not in substitution for the business of the Government of Nauru already assigned to the said Minister.

The above assignment of responsibility for the business of Government of Nauru shall be effective during the absence from the Republic of the Honourable Kenas Aroi, M.P.
