HEALTH DEPARTMENT

MATRON, Nauru General Hospital.

Qualifications: Triple Certificate preferably, with experience in hospital management, tutoring and lecturing.

Duties: The successful applicant will be responsible to the Government Medical Officer for the efficient functioning of the Nauru General Hospital, including oversight of staff and administrative arrangements associated with hospital operation. The duties include comprehensive instruction of trainee nurses in bedside work and techniques and in addition the Matron will be required to give formal medical instruction by lectures to nursing staff (three hours weekly). Nurse critically ill patients and assist at operations.

Assistant Matron, Nauru General Hospital.

Qualifications: At least Double Certificate. Experience in staff supervision and hospital management desirable.

Duties: Under the direction of the Matron responsible for the treatment of patients in the general, maternity, psychiatric and paediatric wards. Supervise the conduct of the baby and ante-natal clinics. Nurse critically ill patients and assist at operations as required. Instruct the cooks in preparation of menus and arrange special diets.
