NAURU LOCAL GOVERNMENT COUNCIL ORDINANCE 1951-1959ELECTION OF COUNCILLORSNOMINATION DAY

It is notified for general information that pursuant to Section 3 of the Nauru Local Government Council Ordinance 1951-1959 that

SATURDAY, the 28th day NOVEMBER, 1959

shall be NOMINATION DAY in accordance with the provisions of the Ordinance for the purposes of the Election of Councillors to be held on Saturday, 12th December, 1959.

Nominations in the form prescribed by the Ordinance must be delivered to the Returning Officer.

In conformity with Section 21 of the Nauru Local Government Council Ordinance 1951-1959, Nomination Forms completed in the prescribed manner will be received by the Returning Officer:-

1. At the office of the Returning Officer at the Administration Offices in the District of Yaren up to 11 o'clock in the morning of Nomination Day.
2. Thereafter, at the Domaneab up to, but not later than noon of Nomination Day.

The nomination of a candidate for Councillor for a District or group of Districts must be signed by two electors of that District or group of Districts and also by the candidate.

Nomination forms are now available at the office of the Nauruan Affairs Branch and at the office of the Returning Officer at the Administration Offices in the District of Yaren.
