APPOINTMENT OF CABINET UNDER ARTICLE 21

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT,
UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, CABINET
HEREBY APPOINTS THE HONOURABLE BERNARD DOWIYOGO, M.P.
BEING THE MINISTER FOR JUSTICE AND A MEMBER OF THE
CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE
THE FUNCTIONS OF THE PRESIDENT IN NAURU UNTIL HIS
EXCELLENCY PRESIDENT HAMMER DEROBURT, G.C.M.G., O.B.E., M.P.
SHALL RETURN TO NAURU OR UNTIL THE RETURN TO NAURU OF THE
HONOURABLE BURARO DETUDAMO, MINISTER FOR WORKS AND COMMUNITY
SERVICES, WHICHEVER SHALL FIRST OCCUR.

CONSTITUTION OF NAURU
ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS
OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, BURARO DETUDAMO, BEING THE MINISTER EXERCISING THE FUNCTIONS OF HIS EXCELLENCY THE PRESIDENT IN NAURU UNDER AND BY VIRTUE OF APPOINTMENT AS SUCH BY CABINET UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, HEREBY ASSIGN TO THE MINISTER OF THE CABINET OF NAURU AS SET OUT BELOW THE RESPONSIBILITIES OF THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE HIS NAME:

MINISTER OF CABINET:

MINISTER FOR HEALTH

THE PORTFOLIO OF THE MINISTER
FOR WORKS AND COMMUNITY SERVICES
IN RELATION TO THE BUSINESS OF
GOVERNMENT TO BE UNDERTAKEN IN
NAURU BY THE SAID MINISTER.

THE ASSIGNMENTS OF BUSINESS OF GOVERNMENT OF NAURU AS SET OUT ABOVE IS IN ADDITION TO AND NOT IN SUBSTITUTION FOR THE BUSINESS OF GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTER. THE ABOVE ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT SHALL BE EFFECTIVE DURING THE ABSENCE FROM THE REPUBLIC OF THE HONOURABLE BURARO DETUDAMO, M.P. MINISTER FOR WORKS AND COMMUNITY SERVICES.
