Having thus received an absolute majority of votes cast Rene HARRIS is declared elected.

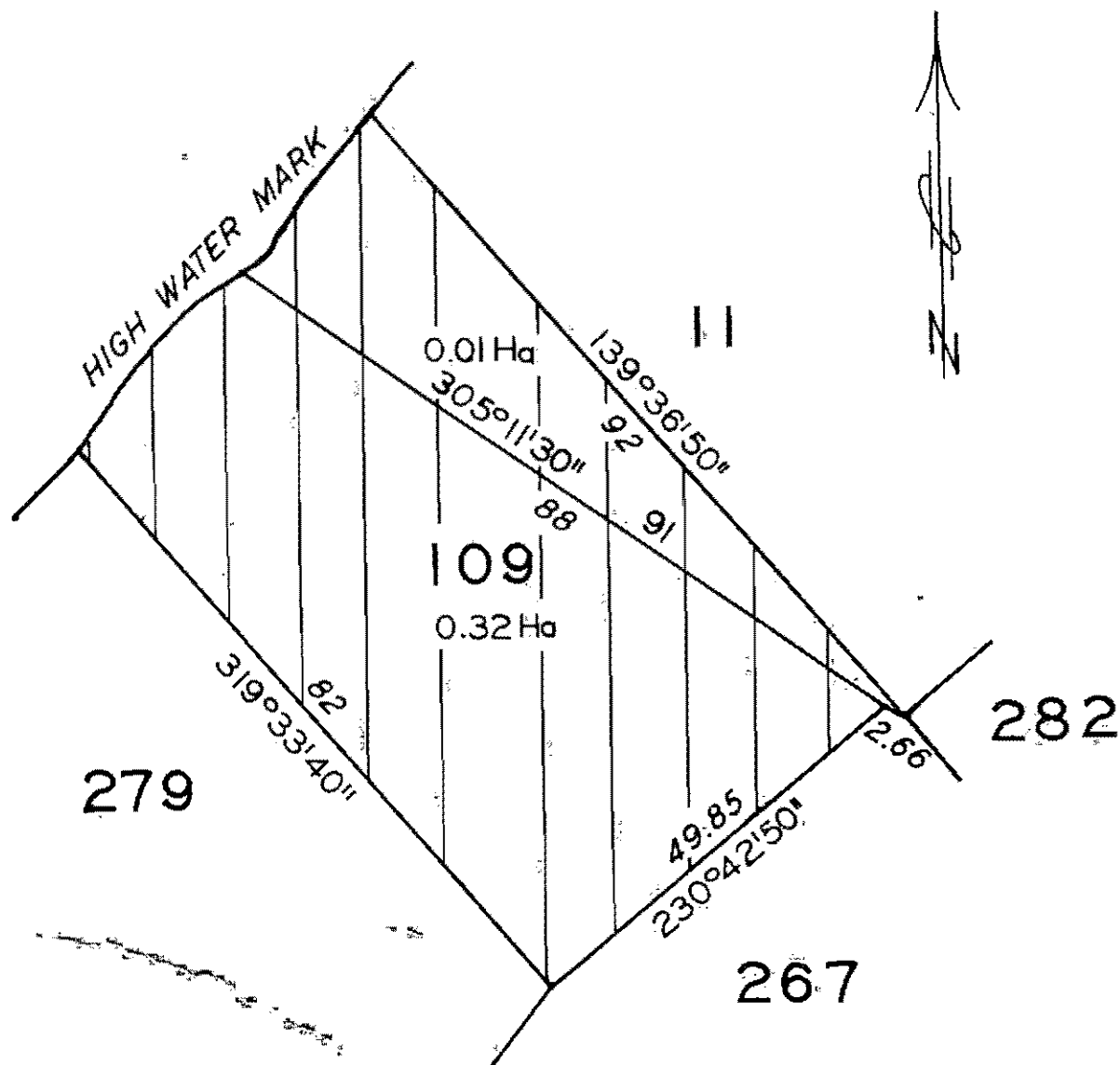
CLASSIFICATION OF LAND
