#### ELECTION OF COUNCILLORS

It is notified for general information that a poll shall be taken between the hours of one o'clock in the afternoon and six o'clock in the afternoon on the 21st day of December 1963 to elect Councillors:

For the Group of Districts comprising the Districts of Anibare, Ijuw, and Anibar - One Councillor to be elected.

For the District of Meneng - One Councillor to be elected.

The candidates duly nominated for election and whose names will appear on the electoral district ballot papers are as follows:-

For the Group of Districts of Anabar, Ijuw and Anibare	Agoko James Doguape - Jerry Ainungom Waldabu Peter Gadaraoa
For the District of Meneng	- James Ategan Bop James Aingimea

The polling places to be used for the purposes of the poll are:-

For	the	District	of	Anabar		Anabar Meeting Place/Catchment shed.
For	the	District	of	Ijuw .	-	Ijuw Meeting Place/Catchment shed.
For	the	District	of	Anibare	-	Anibare Meeting Place/Catchment shed.
For	the	District	of	Meneng		Meneng Infant School.

Every elector, whose name is entered upon the roll for a relative District, shall be entitled to vote and must vote at the Election of a Councillor for that District or Group of Districts in which that District is included.

An elector shall vote at the polling place in the District in which he is enrolled.

The election shall be by ballot and the result of the polling shall be ascertained by scrutiny of the ballot papers in accordance with the indicated preferences of the whole of the votes in the Electoral District.

The ballot paper will be handed to the elector at the polling place for the District for which he or she is enrolled. It will contain the name of each candidate who is standing for election in that District or Group of Districts.

It is essential that the elector show his or her preference for each candidate whose name is stated on the ballot paper. The elector's preference is shown in the order of his or her choice for every candidate by placing the number "1" in the square to the left of the name of the candidate of his or her first choice, by placing the number 2" in the square to the left of the name of the candidate of his or her second choice, and so on as to indicate his or her preferential choice for every candidate shown on the ballot paper.

It is necessary that the elector's intention be clear, that numbers be used on the ballot paper and that no mark other than numbers be placed on the ballot paper, otherwise the ballot paper must be rejected as informal.
