GENERAL NOTICE

REGISTRATION OF BUSINESS NAMES ACT 1976

The public are advised that all persons or corporations carrying on any business in Nauru under a name other than -

- (a) in the case of an individual, the proper name of that individual.
- (b) in the case of a firm - the proper names of all persons comprising that firm,
- (c) in the case of a corporation - the corporate name,

are required to register such name under which they carry on business with the Registrar of Business Names.

Any persons or corporations commencing any business in Nauru under any name other than as mentioned in (a), (b) or (c) above are required to register such business name with the Registrar of Business Names not later than 14 days after commencing business.

Any persons or corporations who so fail to register a business name are liable to a fine of \$10 for each day they carry on business without registering such name and may not without the leave of Court take any legal proceedings to enforce any contract entered into by them.

The forms for registration of a business name may be obtained from and when completed lodged with Central Registry, Government Buildings, Yaren District during the normal working hours of the Public Service.

The public are advised that the Director of Public Prosecutions has granted an amnesty from prosecution of persons who are required to register a business name and who have so failed to do so and who do so before the 10th day of November 1978.
