SECTION 27(2) - NAURUAN BASIC WAGE

IN EXERCISE of the powers vested in me, under Section 27, sub-section (2) of the Public Service Act 1961-1979, I, BURARO DETUDAMO, Acting President and Minister responsible for the Public Service, on the basis of a review of the Retail Price Index of Commodities, DO HEREBY DETERMINE that the following basic wage rates shall take effect from the 15th May 1986:-

Adult	-	\$6,154
20 years (90%)	-	\$5,539
19 years (70%)	-	\$4,308
18 years (60%)	-	\$3,692
17 years (55%)	-	\$3,385
16 years (50%)	-	\$3,077
