#### TREASURY DEPARTMENT

POSITION: Secretary for Finance

SALARY: \$11,184 - \$12,624 (S2) local rates

DUTIES: As permanent Head of the Department of Finance the appointee will be responsible to the Minister for Finance for:-

1. Administration of the Department of Finance, which includes the Government Treasury. There is a staff of approximately forty including qualified Accountants. The Department is primarily responsible for the maintenance of a centralised accounting system and for the management of postal, philatelic and other services.

2. Review, investigation and consolidation of proposed revenue and expenditure budgets of all Government Departments; submission of Finance Bills to Cabinet; assistance with associated parliamentary requirements.
3. Maintenance and supervision of effective budgetary and other accounting controls over revenues, expenditures, expenditure commitments, assets and liabilities of all government departments; management of government financial resources; preparation of monthly and annual financial statements of the Republic.
4. Recommendations to Government on financial policies.

**QUALIFICATIONS:**

Degree in economics or commerce or equivalent professional accounting qualifications. Considerable experience and ability in financial administration at a senior level, preferably including experience of Government financial procedures.
