WHEREAS by section forty-six (k) of the CUSTOMS ORDINANCE 1921 for the Territory of New Guinea adopted as a law of the Island of Nauru it is provided, that the Administrator may by Proclamation prohibit the import of goods:

and WHEREAS the Administrator did prohibit the import from Australia of birds including live poultry and poultry products by Proclamation dated 21st February 1966:

NOW THEREFORE I, ROY EDWARD VIZARD, the ACTING ADMINISTRATOR of the Territory of Nauru, acting in accordance with the provisions of Section 29 of the Interpretation Ordinance 1956-1965 do hereby revoke the prohibition aforesaid.
