Cabinet makes the following Regulations under section 12 of the *Customs Tariff Act* 2014:

**1 Citation**

These Regulations may be cited as the *Customs Tariff (Alteration to Tariff) Regulations 2017*.

**2 Commencement**

These Regulations commence on the day they are notified in the Gazette.

**3 Alteration of Schedule 1**

(1) Schedule 1 is amended by removing the existing tariff from sub-heading 22.03 to 22.08 and substituting it with the following:
